## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2157a. (1) For purposes of this section:
- 2 (a) "Confidential communication" means information transmitted
- 3 between a victim and a sexual assault, or domestic violence, OR
- 4 HUMAN TRAFFICKING counselor, or between a victim or sexual assault,
- 5 or domestic violence, OR HUMAN TRAFFICKING counselor and any other
  - person to whom disclosure is reasonably necessary to further the
  - interests of the victim, in connection with the rendering of
  - advice, counseling, or other assistance by the sexual assault, or
- 9 domestic violence, OR HUMAN TRAFFICKING counselor to the victim.
  - (b) "Domestic violence" means that term as defined in section

- 3 shall IS not be admissible as evidence in any civil or criminal
- 4 proceeding without the prior written consent of the victim.
- 5 Enacting section 1. This amendatory act takes effect 90 days
- 6 after the date it is enacted into law.
