A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.713) by adding section 280.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 280. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
- 2 2018, SUBJECT TO THE LIMITATIONS UNDER THIS SECTION A TAXPAYER MAY
- 3 CLAIM A CREDIT AGAINST THE TAX IMPOSED BY THIS PART EQUAL TO THE
- 4 AMOUNT PAID DURING THE TAX YEAR FOR TEXTBOOKS PURCHASED AND USED BY
- 5 THE TAXPAYER OR A DEPENDENT OF THE TAXPAYER THAT ARE REQUIRED FOR
- 6 CLASSES TAKEN BY THE TAXPAYER OR A DEPENDENT OF THAT TAXPAYER FOR
- 7 THAT SAME TAX YEAR AT AN INSTITUTION OF HIGHER EDUCATION IN THIS
- 8 STATE. A TAXPAYER SHALL NOT INCLUDE ANY PAYMENTS MADE FOR TEXTBOOKS
 - THAT WERE PAID FROM AN EDUCATION SAVINGS ACCOUNT OR ANY PAYMENTS

- 18 (C) "INSTITUTION OF HIGHER EDUCATION" MEANS A PUBLIC COLLEGE,
- 19 UNIVERSITY, COMMUNITY COLLEGE, JUNIOR COLLEGE, OR TRADE,
- 20 VOCATIONAL, OR OCCUPATIONAL SCHOOL THAT OFFERS A DEGREE OR
- 21 CERTIFICATE.
