26 **(A) BEGINNING JANUARY 1, 2019, \$10.00.**

27 **(B) BEGINNING JANUARY 1, 2020, \$10.65.**

1 (C) BEGINNING JANUARY 1, 2021, \$11.35.

2 (D) BEGINNING JANUARY 1, 2022, \$12.00.

3 (2) EVERY OCTOBER BEGINNING IN 2022, THE STATE TREASURER SHALL
4 CALCULATE AN ADJUSTED MINIMUM HOURLY WAGE RATE. THE STATE TREASURER
5 SHALL CALCULATE THE ADJUSTED MINIMUM HOURLY WAGE RATE BY
6 MULTIPLYING THE OTHERWISE APPLICABLE MINIMUM HOURLY WAGE RATE BY
7 THE 12-MONTH PERCENTAGE INCREASE, IF ANY, IN THE CONSUMER PRICE
8 INDEX FOR URBAN WAGE EARNERS AND CLERICAL WORKERS, CPI-W, OR A
9 SUCCESSOR INDEX, AS PUBLISHED BY THE BUREAU OF LABOR STATISTICS OF
10 THE UNITED STATES DEPARTMENT OF LABOR, BASED ON THE MOST RECENT 12-
11 MONTH PERIOD FOR WHICH DATA ARE AVAILABLE. THE STATE TREASURER
12 SHALL PUBLISH THE ADJUSTED MINIMUM HOURLY WAGE RATE BY NOVEMBER 1
13 OF THE YEAR IT IS CALCULATED. THE ADJUSTED MINIMUM HOURLY WAGE RATE
14 IS EFFECTIVE BEGINNING JANUARY 1 OF THE SUCCEEDING YEAR.

14 **EMPLOYEE WHO RECEIVES THEM, EXCEPT AS VOLUNTARILY SHARED WITH OTHER**
15 **EMPLOYEES WHO ARE DIRECTLY OR INDIRECTLY PART OF THE CHAIN OF**
16 **SERVICE AND WHOSE DUTIES ARE NOT PRIMARILY MANAGERIAL OR**
17 **SUPERVISORY.**

18 **(E) ~~(d)~~** The employee was informed by the employer of the
19 provisions of this section, **IN WRITING, AT OR BEFORE THE TIME OF**
20 **HIRE, AND GAVE WRITTEN CONSENT.**

21 **(2) THE MINIMUM HOURLY WAGE RATE OF AN EMPLOYEE THAT MEETS THE**
22 **REQUIREMENTS OF SUBSECTION (1) IS:**

23 **(A) BEGINNING JANUARY 1, 2019, 48% OF THE MINIMUM HOURLY WAGE**
24 **RATE ESTABLISHED UNDER SECTION 4.**

25 **(B) BEGINNING JANUARY 1, 2020, 60% OF THE MINIMUM HOURLY WAGE**
26 **RATE ESTABLISHED UNDER SECTION 4.**

27 **(C) BEGINNING JANUARY 1, 2021, 70% OF THE MINIMUM HOURLY WAGE**

1 RATE ESTABLISHED UNDER SECTION 4.

2 (D) BEGINNING JANUARY 1, 2022, 80% OF THE MINIMUM HOURLY WAGE
3 RATE ESTABLISHED UNDER SECTION 4.

4 (E) BEGINNING JANUARY 1, 2023, 90% OF THE MINIMUM HOURLY WAGE
5 RATE ESTABLISHED UNDER SECTION 4.

6 (F) BEGINNING JANUARY 1, 2024, 100% OF THE MINIMUM HOURLY WAGE
7 RATE ESTABLISHED UNDER SECTION 4.

8 (3) ~~(2)~~—As used in this section, "gratuities" means tips or
9 voluntary monetary contributions received by an employee from a
10 guest, patron, or customer for services rendered to that guest,
11 patron, or customer and that the employee reports to the employer
12 for purposes of the federal insurance contributions act, 26 USC
13 3101 to 3128.

14 (4) GRATUITIES REMAIN PROPERTY OF THE EMPLOYEE WHO RECEIVES
15 THEM, EXCEPT PURSUANT TO A VALID AND VOLUNTARY TIP SHARING
16 AGREEMENT DESCRIBED IN SUBSECTION (1) (D), REGARDLESS OF WHETHER THE
17 EMPLOYER PAYS THE LOWER TIPPED HOURLY WAGE ESTABLISHED UNDER
18 SUBSECTION (2) OR THE FULL MINIMUM HOURLY RATE ESTABLISHED UNDER
19 SECTION 4. GRATUITIES AND SERVICE CHARGES PAID TO AN EMPLOYEE ARE
20 IN ADDITION TO, AND DO NOT COUNT TOWARD, WAGES DUE THE EMPLOYEE.

21 (5) AN EMPLOYER SHALL PROVIDE EMPLOYEES AND CONSUMERS WRITTEN
22 NOTICE OF ITS INTENT TO DISTRIBUTE SERVICE CHARGES.

23 (6) AN EMPLOYER SHALL KEEP RECORDS SHOWING COMPLIANCE WITH
24 THIS SECTION FOR AT LEAST 3 YEARS AFTER THE DATE OF AN EMPLOYEE'S
25 LAST PAY PERIOD.
