PROVISIONS CONCERNING APPROPRIATIONS

**GENERAL SECTIONS**

9           Sec. 201. In accordance with section 30 of article IX of the  
10 state constitution of 1963, total state spending from state sources  
11 in this appropriation act for the fiscal year ending September 30,  
12 2020 is \$971,000.00 and state spending from state sources to be  
13 paid to local units of government is \$0.00.

14           Sec. 202. The appropriations made and expenditures authorized  
15 under this act and the departments, commissions, boards, offices,  
16 and programs for which appropriations are made under this act are  
17 subject to the management and budget act, 1984 PA 431, MCL 18.1101  
18 to 18.1594.

**DEPARTMENT OF LABOR AND ECONOMIC OPPORTUNITY**

21           Sec. 301. From the funds appropriated in part 1 for Michigan  
22 enhancement grants, \$971,000.00 shall be awarded for a retirement  
23 funding shortfall at an association established to provide services  
24 and support to Michigan's workforce development system located in a  
25 county with a population of between 16,000 and 17,000 according to  
26 the most recent federal decennial census.
