## SUBSTITUTE FOR HOUSE BILL NO. 5974

A bill to amend 1939 PA 288, entitled "Probate code of 1939,"

by amending section 13a of chapter XIIA (MCL 712A.13a), as amended by 2016 PA 191.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 CHAPTER XIIA
- 2 Sec. 13a. (1) As used in this section and sections 2, 6b, 13b,
- **3** 17c, 17d, 18f, 19, 19a, 19b, and 19c of this chapter:
- 4 (a) "Agency" means a public or private organization,
- 5 institution, or facility that is performing the functions under
- 6 part D of title IV of the social security act, 42 USC 651 to 669b,
- 7 or that is responsible under court order or contractual arrangement
- 8 for a juvenile's care and supervision.

- 1 (b) "Agency case file" means the current file from the agency
  2 providing direct services to the child, that can may include the
  3 child protective services file if the child has not been removed
  4 from the home or the department or contract agency foster care file
  5 as provided under 1973 PA 116, MCL 722.111 to 722.128.
- 6 (c) "Attorney" means, if appointed to represent a child in a 7 proceeding under section 2(b) or (c) of this chapter, an attorney 8 serving as the child's legal advocate in a traditional attorney-9 client relationship with the child, as governed by the Michigan 10 rules of professional conduct. Rules of Professional Conduct. An 11 attorney defined under this subdivision owes the same duties of 12 undivided loyalty, confidentiality, and zealous representation of 13 the child's expressed wishes as the attorney would to an adult 14 client. For the purpose of a notice required under these sections, 15 attorney includes a child's lawyer-quardian ad litem.
  - (d) "Case service plan" means the plan developed by an agency and prepared under section 18f of this chapter that includes services to be provided by and responsibilities and obligations of the agency and activities, responsibilities, and obligations of the parent. The case service plan may be referred to using different names than case service plan including, but not limited to, a parent/agency agreement or a parent/agency treatment plan and service agreement.
  - (e) "Foster care" means care provided to a juvenile in a foster family home, foster family group home, or child caring institution licensed or approved under 1973 PA 116, MCL 722.111 to 722.128, or care provided to a juvenile in a relative's home under a court order.
- 29 (f) "Guardian ad litem" means an individual whom the court

- 1 appoints to assist the court in determining the child's best
- 2 interests. A guardian ad litem does not need to be an attorney.
- 3 (g) "Lawyer-guardian ad litem" means an attorney appointed
- 4 under section 17c of this chapter. A lawyer-quardian ad litem
- 5 represents the child, and has the powers and duties, as set forth
- 6 in section 17d of this chapter. The provisions of section 17d of
- 7 this chapter also apply to a lawyer-guardian ad litem appointed
- 8 under each of the following:
- 9 (i) Section 5213 or 5219 of the estates and protected
- 10 individuals code, 1998 PA 386, MCL 700.5213 and 700.5219.
- 11 (ii) Section 4 of the child custody act of 1970, 1970 PA 91,
- **12** MCL 722.24.
- 13 (iii) Section 10 of the child protection law, 1975 PA 238, MCL
- **14** 722.630.
- 15 (h) "Nonparent adult" means a person who is 18 years of age or
- 16 older and who, regardless of the person's domicile, meets all of
- 17 the following criteria in relation to a child over whom the court
- 18 takes jurisdiction under this chapter:
- (i) Has substantial and regular contact with the child.
- (ii) Has a close personal relationship with the child's parent
- 21 or with a person responsible for the child's health or welfare.
- 22 (iii) Is not the child's parent or a person otherwise related to
- 23 the child by blood or affinity to the third degree.
- 24 (i) "Permanent foster family agreement" means an agreement for
- 25 a child 14 years old or older to remain with a particular foster
- 26 family until the child is 18 years old under standards and
- 27 requirements established by the department, which agreement is
- 28 among all of the following:
- 29 (i) The child.

- 1 (ii) If the child is a temporary ward, the child's family.
- 2 (iii) The foster family.
- (iv) The child placing agency responsible for the child's care in foster care.
- 5 (j) "Relative" means an individual who is at least 18 years of6 age and related is either of the following:
- 7 (i) Related to the child within the fifth degree by blood, 8 marriage, or adoption, as grandparent, great-grandparent, great-9 great-grandparent, aunt or uncle, great-aunt or great-uncle, great-10 great-aunt or great-great-uncle, sibling, stepsibling, nephew or 11 niece, first cousin or first cousin once removed, and including the spouse of any of the above, an individual related to the child 12 within the fifth degree, even after the marriage has ended by death 13 14 or divorce, . A stepparent, ex-stepparent, or the parent who shares custody of a half-sibling, shall be considered a relative for the 15 16 purpose of placement. Notification to the stepparent, ex-17 stepparent, or the parent who shares custody of a half-sibling is 18 required as described in section 4a of the foster care and adoption 19 services act, 1994 PA 203, MCL 722.954a. A child may be placed with 20 and the parent of a man whom the court has found probable cause to 21 believe is the putative father if there is no man with legally 22 established rights to the child. A placement with the parent of a 23 putative father under this subdivision is not a finding of 24 paternity and does not confer legal standing on the putative 25 father.
  - (ii) Not related to a child within the fifth degree by blood, marriage, or adoption but who has a strong positive emotional tie or role in the child's life or the child's parent's life if the child is an infant, as determined by the department or, if the

- 1 child is an Indian child, as determined solely by the Indian
- 2 child's tribe. As used in this section, "Indian child" and "Indian
- 3 child's tribe" mean those terms as defined in section 3 of chapter
- 4 XIIB.
- 5 (k) "Sex offenders registration act" means the sex offenders
- 6 registration act, 1994 PA 295, MCL 28.721 to 28.736.28.730.
- 7 (l) "Sibling" means a child who is related through birth or
- 8 adoption by at least 1 common parent. Sibling includes that term as
- 9 defined by the an American Indian or Alaskan native child's tribal
- 10 code or custom.
- 11 (2) If a juvenile is alleged to be within the provisions of
- 12 section 2(b) of this chapter, the court may authorize a petition to
- 13 be filed at the conclusion of the preliminary hearing or inquiry.
- 14 The court may authorize the petition upon a showing of probable
- 15 cause that 1 or more of the allegations in the petition are true
- 16 and fall within the provisions of section 2(b) of this chapter. If
- 17 a petition is before the court because the department is required
- 18 to submit the petition under section 17 of the child protection
- 19 law, 1975 PA 238, MCL 722.637, the court shall hold a hearing on
- 20 the petition within 24 hours or on the next business day after the
- 21 petition is submitted, at which hearing the court shall consider at
- 22 least the matters governed by subsections (4) and (5).
- 23 (3) Except as provided in subsections (5) and (6), if a
- 24 petition under subsection (2) is authorized, the court may release
- 25 the juvenile in the custody of either of the juvenile's parents or
- 26 the juvenile's quardian or custodian under reasonable terms and
- 27 conditions necessary for either the juvenile's physical health or
- 28 mental well-being.
- 29 (4) The court may order a parent, guardian, custodian,

- 1 nonparent adult, or other person residing in a child's home to
- 2 leave the home and, except as the court orders, not to subsequently
- 3 return to the home if all of the following take place:
- 4 (a) A petition alleging abuse of the child by the parent,
- 5 guardian, custodian, nonparent adult, or other person is authorized
- 6 under subsection (2).
- 7 (b) The court after a hearing finds probable cause to believe
- 8 the parent, guardian, custodian, nonparent adult, or other person
- 9 committed the abuse.
- 10 (c) The court finds on the record that the presence in the
- 11 home of the person alleged to have committed the abuse presents a
- 12 substantial risk of harm to the child's life, physical health, or
- 13 mental well-being.
- 14 (5) If a petition alleges abuse by a person described in
- 15 subsection (4), regardless of whether the court orders the alleged
- 16 abuser to leave the child's home under subsection (4), the court
- 17 shall not leave the child in or return the child to the child's
- 18 home or place the child with a person not licensed under 1973 PA
- 19 116, MCL 722.111 to 722.128, unless the court finds that the
- 20 conditions of custody at the placement and with the individual with
- 21 whom the child is placed are adequate to safeguard the child from
- 22 the risk of harm to the child's life, physical health, or mental
- 23 well-being.
- 24 (6) If a court finds a parent is required by court order to
- 25 register under the sex offenders registration act, the department
- 26 may, but is not required to, make reasonable efforts to reunify the
- 27 child with the parent. The court may order reasonable efforts to be
- 28 made by the department.
- 29 (7) In determining whether to enter an order under subsection

- 1 (4), the court may consider whether the parent who is to remain in
- 2 the juvenile's home is married to the person to be removed or has a
- 3 legal right to retain possession of the home.
- 4 (8) An order entered under subsection (4) may also contain 1 5 or more of the following terms or conditions:
- **6** (a) The court may require the alleged abusive parent to pay
- 7 appropriate support to maintain a suitable home environment for the
- 8 juvenile during the duration of the order.
- 9 (b) The court may order the alleged abusive person, according
- 10 to terms the court may set, to surrender to a local law enforcement
- 11 agency any firearms or other potentially dangerous weapons the
- 12 alleged abusive person owns, possesses, or uses.
- 13 (c) The court may include any reasonable term or condition
- 14 necessary for the juvenile's physical or mental well-being or
- 15 necessary to protect the juvenile.
- 16 (9) The court may order placement of the child in foster care
- 17 if the court finds all of the following conditions:
- 18 (a) Custody of the child with the parent presents a
- 19 substantial risk of harm to the child's life, physical health, or
- 20 mental well-being.
- 21 (b) No provision of service or other arrangement except
- 22 removal of the child is reasonably available to adequately
- 23 safeguard the child from risk as described in subdivision (a).
- 24 (c) Continuing the child's residence in the home is contrary
- 25 to the child's welfare.
- 26 (d) Consistent with the circumstances, reasonable efforts were
- 27 made to prevent or eliminate the need for removal of the child.
- 28 (e) Conditions of child custody away from the parent are
- 29 adequate to safeguard the child's health and welfare.

- 1 (10) If the court orders placement of the juvenile outside the
- 2 juvenile's home, the court shall inform the parties of the
- 3 following:
- 4 (a) That the agency has the responsibility to prepare an
- 5 initial services plan within 30 days of the juvenile's placement.
- 6 (b) The general elements of an initial services plan as
- 7 required by the rules promulgated under 1973 PA 116, MCL 722.111 to
- **8** 722.128.
- 9 (c) That participation in the initial services plan is
- 10 voluntary without a court order.
- 11 (11) Before or within 7 days after a child is placed in a
- 12 relative's home, the department shall perform a criminal record
- 13 check and central registry clearance. If the child is placed in the
- 14 home of a relative, the court shall order a home study to be
- 15 performed and a copy of the home study to be submitted to the court
- 16 not more than 30 days after the placement.
- 17 (12) In determining placement of a juvenile pending trial, the
- 18 court shall order the juvenile placed in the most family-like
- 19 setting available consistent with the juvenile's needs.
- 20 (13) If a juvenile is removed from the parent's custody at any
- 21 time, the court shall permit the juvenile's parent to have regular
- 22 and frequent parenting time with the juvenile. Parenting time
- 23 between the juvenile and his or her parent shall must not be less
- 24 than 1 time every 7 days unless the court determines either that
- 25 exigent circumstances require less frequent parenting time or that
- 26 parenting time, even if supervised, may be harmful to the
- 27 juvenile's life, physical health, or mental well-being. If the
- 28 court determines that parenting time, even if supervised, may be
- 29 harmful to the juvenile's life, physical health, or mental well-

- 1 being, the court may suspend parenting time until the risk of harm
- 2 no longer exists. The court may order the juvenile to have a
- 3 psychological evaluation or counseling, or both, to determine the
- 4 appropriateness and the conditions of parenting time.
- 5 (14) Reasonable efforts shall must be made to do the following:
- 7 (a) Place siblings removed from their home in the same foster
- 8 care, kinship guardianship, or adoptive placement, unless the
- 9 supervising agency documents that a joint placement would be
- 10 contrary to the safety or well-being of any of the siblings.
- 11 (b) In the case of siblings removed from their home who are
- 12 not jointly placed, provide for visitation, at least monthly, or
- 13 other ongoing interaction between the siblings, unless the
- 14 supervising agency documents that visitation, at least monthly, or
- 15 other ongoing interaction would be contrary to the safety or well-
- 16 being of any of the siblings.
- 17 (15) If the supervising agency documents that visitation or
- 18 other contact is contrary to the safety or well-being of any of the
- 19 siblings and temporarily suspends visitation or contact, the
- 20 supervising agency shall report its determination to the court for
- 21 consideration at the next review hearing.
- 22 (16) If the supervising agency temporarily suspends visitation
- 23 or contact, the court shall review the decision and determine
- 24 whether sibling visitation or contact will be beneficial to the
- 25 siblings. If so, the court shall order sibling visitation or
- 26 contact to the extent reasonable.
- 27 (17) Upon the motion of any party, the court shall review
- 28 custody and placement orders and initial services plans pending
- 29 trial and may modify those orders and plans as the court considers

- 1 under this section are is in the juvenile's best interests.
- 2 (18) The court shall include in an order placing a child in
- 3 foster care an order directing the release of information
- 4 concerning the child in accordance with this subsection. If a child
- 5 is placed in foster care, within 10 days after receipt of a written
- 6 request, the agency shall provide the person who is providing the
- 7 foster care with copies of all initial, updated, and revised case
- 8 service plans and court orders relating to the child and all of the
- 9 child's medical, mental health, and education reports, including
- 10 reports compiled before the child was placed with that person.
- 11 (19) In an order placing a child in foster care, the court
- 12 shall include both of the following:
- 13 (a) An order that the child's parent, guardian, or custodian
- 14 provide the supervising agency with the name and address of each of
- 15 the child's medical providers.
- 16 (b) An order that each of the child's medical providers
- 17 release the child's medical records. The order may specify
- 18 providers by profession or type of institution.
- 19 (20) As used in this section, "abuse" means 1 or more of the
- 20 following:
- 21 (a) Harm or threatened harm by a person to a juvenile's health
- 22 or welfare that occurs through nonaccidental physical or mental
- 23 injury.
- 24 (b) Engaging in sexual contact or sexual penetration as those
- 25 terms are defined in section 520a of the Michigan penal code, 1931
- 26 PA 328, MCL 750.520a, with a juvenile.
- 27 (c) Sexual exploitation of a juvenile, which includes, but is
- 28 not limited to, allowing, permitting, or encouraging a juvenile to
- 29 engage in prostitution or allowing, permitting, encouraging, or

- 1 engaging in photographing, filming, or depicting a juvenile engaged
- 2 in a listed sexual act as that term is defined in section 145c of
- 3 the Michigan penal code, 1931 PA 328, MCL 750.145c.
- 4 (d) Maltreatment of a juvenile.
