## SUBSTITUTE FOR HOUSE BILL NO. 4486

A bill to amend 1974 PA 258, entitled "Mental health code,"

by amending the title and sections 100b, 100c, 100d, 260, 276, 277, 278, 279, 281, 282, 283, 286, and 464a (MCL 330.1100b, 330.1100c, 330.1100d, 330.1260, 330.1276, 330.1277, 330.1278, 330.1279, 330.1281, 330.1282, 330.1283, 330.1286, and 330.1464a), the title as amended by 1995 PA 290, sections 100b, 100c, and 100d as amended and sections 260, 276, 277, 278, 279, 281, 282, 283, and 286 as added by 2012 PA 500, and section 464a as added by 1994 PA 339, and by adding sections 281a, 281b, and 281c.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 TITLE

2 An act to codify, revise, consolidate, and classify the laws

- 1 relating to mental health; to prescribe the powers and duties of
- 2 certain state and local agencies and officials and certain private
- 3 agencies and individuals; to regulate certain agencies and
- 4 facilities providing mental health OR SUBSTANCE USE DISORDER

- 14 care or treatment of individuals with serious mental illness,

- 17 (2) "Family" as used in sections 156 to 161 means an eligible
- 18 minor and his or her parent or legal guardian.
- 19 (3) "Family member" means a parent, stepparent, spouse,
- 20 sibling, child, or grandparent of a primary consumer, or an
- 21 individual upon whom a primary consumer is dependent for at least
- 22 50% of his or her financial support.
- 23 (4) "Federal funds" means funds received from the federal
- 24 government under a categorical grant or similar program and does
- 25 not include federal funds received under a revenue sharing
- 26 arrangement.
- 27 (5) "Functional impairment" means both of the following:

- 1 (a) With regard to serious emotional disturbance, substantial
- 2 interference with or limitation of a minor's achievement or
- 3 maintenance of 1 or more developmentally appropriate social,
- 4 behavioral, cognitive, communicative, or adaptive skills.
- 5 (b) With regard to serious mental illness, substantial
- 6 interference or limitation of role functioning in 1 or more major
- 7 life activities including basic living skills such as eating,
- 8 bathing, and dressing; instrumental living skills such as
- 9 maintaining a household, managing money, getting around the
- 10 community, and taking prescribed medication; and functioning in
- 11 social, vocational, and educational contexts.
- 12 (6) "Guardian" means a person appointed by the court to
- 13 exercise specific powers over an individual who is a minor, legally
- 14 incapacitated, or developmentally disabled.
- 15 (7) "Hospital" or "psychiatric hospital" means an inpatient
- 16 program operated by the department for the treatment of individuals
- 17 with serious mental illness or serious emotional disturbance or a
- 18 psychiatric hospital or psychiatric unit licensed under section
- **19** 137.
- 20 (8) "Hospital director" means the chief administrative officer
- 21 of a hospital or his or her designee.
- 22 (9) "Hospitalization" or "hospitalize" means to provide
- 23 treatment for an individual as an inpatient in a hospital.
- 24 (10) "Incapacitated" means that an individual, as a result of
- 25 the use of alcohol OR OTHER DRUGS, is unconscious or has his or her
- 26 mental or physical functioning so impaired that he or she either
- 27 poses an immediate and substantial danger to his or her own health

- 1 and safety or is endangering the health and safety of the public.
- 2 (11) "Individual plan of services" or "plan of services" means
- 3 a written individual plan of services developed with a recipient as
- 4 required by section 712.
- 5 (12) "Licensed facility" means a facility licensed by the
- 6 department under section 137 or an adult foster care facility.
- 7 (13) "Licensed psychologist" means a doctoral level
- 8 psychologist licensed under section 18223(1) of the public health
- 9 code, 1978 PA 368, MCL 333.18223.
- 10 (14) "Medical director" means a psychiatrist appointed under
- 11 section 231 to advise the executive director of a community mental
- 12 health services program.
- 13 (15) "Mental health professional" means an individual who is
- 14 trained and experienced in the area of mental illness or
- 15 developmental disabilities and who is 1 of the following:
- 16 (a) A physician.
- 17 (b) A psychologist. <del>licensed to practice in this state under</del>
- 18 article 15 of the public health code, 1978 PA 368, MCL 333.16101 to
- **19** 333.18838.
- 20 (c) A registered professional nurse licensed OR OTHERWISE
- 21 AUTHORIZED to ENGAGE IN THE practice in this state OF NURSING under
- 22 article 15 PART 172 of the public health code, 1978 PA 368, MCL
- 23 333.16101 to 333.18838.333.17201 TO 333.17242.
- 24 (d) A licensed master's social worker licensed OR OTHERWISE
- 25 AUTHORIZED TO ENGAGE IN THE PRACTICE OF SOCIAL WORK AT THE MASTER'S
- 26 LEVEL under article 15 PART 185 of the public health code, 1978 PA
- 27 368, MCL <del>333.16101 to 333.18838.</del>333.18501 TO 333.18518.

- 1 (e) A licensed professional counselor licensed OR OTHERWISE
- 2 AUTHORIZED to ENGAGE IN THE practice in this state OF COUNSELING
- 3 under article 15 PART 181 of the public health code, 1978 PA 368,
- 4 MCL <del>333.16101 to 333.18838.</del>333.18101 TO 333.18117.
- 5 (f) A marriage and family therapist licensed OR OTHERWISE
- 6 AUTHORIZED TO ENGAGE IN THE PRACTICE OF MARRIAGE AND FAMILY THERAPY
- 7 under article 15 PART 169 of the public health code, 1978 PA 368,
- 8 MCL <del>333.16101 to 333.18838.</del>333.16901 TO 333.16915.
- 9 (16) "Mental retardation" means a condition manifesting before
- 10 the age of 18 years that is characterized by significantly
- 11 subaverage intellectual functioning and related limitations in 2 or
- 12 more adaptive skills and that is diagnosed based on the following
- 13 assumptions:
- 14 (a) Valid assessment considers cultural and linguistic
- 15 diversity, as well as differences in communication and behavioral
- 16 factors.
- 17 (b) The existence of limitation in adaptive skills occurs
- 18 within the context of community environments typical of the
- 19 individual's age peers and is indexed to the individual's
- 20 particular needs for support.
- 21 (c) Specific adaptive skill limitations often coexist with
- 22 strengths in other adaptive skills or other personal capabilities.
- 23 (d) With appropriate supports over a sustained period, the
- 24 life functioning of the individual with mental retardation will
- 25 generally improve.
- 26 (17) "Minor" means an individual under the age of 18 years.
- 27 (18) "Multicultural services" means specialized mental health

- 1 services for multicultural populations such as African-Americans,
- 2 Hispanics, Native Americans, Asian and Pacific Islanders, and
- 3 Arab/Chaldean-Americans.
- 4 (19) "Neglect" means an act or failure to act committed by an
- 5 employee or volunteer of the department, a community mental health
- 6 services program, or a licensed hospital; a service provider under
- 7 contract with the department, a community mental health services
- 8 program, or a licensed hospital; or an employee or volunteer of a
- 9 service provider under contract with the department, a community
- 10 mental health services program, or a licensed hospital, that denies
- 11 a recipient the standard of care or treatment to which he or she is
- 12 entitled under this act.
- 13 Sec. 100c. (1) "Peace officer" means an officer of the
- 14 department of state police or of a law enforcement agency of a
- 15 county, township, city, or village who is responsible for the
- 16 prevention and detection of crime and enforcement of the criminal
- 17 laws of this state. For the purposes of sections 408 and 427, peace
- 18 officer also includes an officer of the United States secret
- 19 service with the officer's consent and a police officer of the
- 20 veterans' administration medical center reservation.
- 21 (2) "Peer review" means a process, including the review
- 22 process required under section 143a, in which mental health
- 23 professionals of a state facility, licensed hospital, or community
- 24 mental health services program evaluate the clinical competence of
- 25 staff and the quality and appropriateness of care provided to
- 26 recipients. These PEER REVIEW evaluations are confidential in
- 27 accordance with section 748(9) and are based on criteria

- 1 established by the facility or community mental health services
- program itself, the accepted standards of the mental health
- 3 professions, and the department.
- 4 (3) "Person requiring treatment" means an individual who meets
- 5 the criteria described in section 401.
- 6 (4) "Physician" means an individual licensed by the state—OR
- 7 OTHERWISE AUTHORIZED to engage in the practice of medicine UNDER
- 8 PART 170 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.17001 TO
- 9 333.17084, or TO ENGAGE IN THE PRACTICE OF osteopathic medicine and
- 10 surgery under article 15 PART 175 of the public health code, 1978
- 11 PA 368, MCL <del>333.16101 to 333.18838.</del>333.17501 TO 333.17556.
- 12 (5) "Primary consumer" means an individual who has received or
- 13 is receiving services from the department or a community mental
- 14 health services program or services from the private sector
- 15 equivalent to those offered by the department or a community mental
- 16 health services program.
- 17 (6) "Priority" means preference for and dedication of a major
- 18 proportion of resources to specified populations or services.
- 19 Priority does not mean serving or funding the specified populations
- 20 or services to the exclusion of other populations or services.
- 21 (7) "Protective custody" means the temporary custody of an
- 22 individual by a peace officer with or without the individual's
- 23 consent for the purpose of protecting that individual's health and
- 24 safety, or the health and safety of the public, and for the purpose
- 25 of transporting the individual under section 276, 408, or 427 if
- 26 the individual appears, in the judgment of the peace officer, to be
- 27 a person requiring treatment or is a person requiring treatment.

- 1 Protective custody is civil in nature and is not to be construed as
- 2 an arrest.
- 3 (8) "Psychiatric partial hospitalization program" means a
- 4 nonresidential treatment program that provides psychiatric,
- 5 psychological, social, occupational, nursing, music therapy, and
- 6 therapeutic recreational services under the supervision of a
- 7 physician to adults diagnosed as having serious mental illness or
- 8 minors diagnosed as having serious emotional disturbance who do not
- 9 require 24-hour continuous mental health care, and that is
- 10 affiliated with a psychiatric hospital or psychiatric unit to which
- 11 clients may be transferred if they need inpatient psychiatric care.
- 12 (9) "Psychiatric unit" means a unit of a general hospital that
- 13 provides inpatient services for individuals with serious mental
- 14 illness or serious emotional disturbance. As used in this
- 15 subsection, "general hospital" means a hospital as defined in
- 16 section 20106 of the public health code, 1978 PA 368, MCL
- **17** 333.20106.
- 18 (10) "Psychiatrist" means 1 or more of the following:
- 19 (a) A physician who has completed a residency program in
- 20 psychiatry approved by the accreditation council for graduate
- 21 medical education or the American osteopathic association, or who
- 22 has completed 12 months of psychiatric rotation and is enrolled in
- 23 an approved residency program as described in this
- 24 subsection.SUBDIVISION.
- 25 (b) A psychiatrist employed by or under contract with the
- 26 department or a community mental health services program on March
- **27** 28, 1996.

- 1 (c) A physician who devotes a substantial portion of his or
- 2 her time to the practice of psychiatry and is approved by the
- 3 director.
- 4 (11) "Psychologist" means an individual WHO IS licensed OR
- 5 OTHERWISE AUTHORIZED to engage in the practice of psychology under
- 6 article 15 PART 182 of the public health code, 1978 PA 368, MCL
- 7 333.16101 to 333.18838, 333.18201 TO 333.18237, AND who devotes a
- 8 substantial portion of his or her time to the diagnosis and
- 9 treatment of individuals with serious mental illness, serious
- 10 emotional disturbance, SUBSTANCE USE DISORDER, or developmental
- 11 disability.
- 12 (12) "Recipient" means an individual who receives mental
- 13 health services from the department, a community mental health
- 14 services program, or a facility or from a provider that is under
- 15 contract with the department or a community mental health services
- 16 program. For the purposes of this act, recipient does not include
- 17 an individual receiving substance use disorder services under
- 18 chapter 2A unless that individual is also receiving mental health
- 19 services under this act in conjunction with substance use disorder
- 20 services.
- 21 (13) "Recipient rights advisory committee" means a committee
- 22 of a community mental health services program board appointed under
- 23 section 757 or a recipient rights advisory committee appointed by a
- 24 licensed hospital under section 758.
- 25 (14) "Recovery" means a highly individualized process of
- 26 healing and transformation where BY WHICH the individual gains
- 27 control over his or her life. Related services include recovery

- 1 management, recovery support services, recovery houses or
- 2 transitional living programs, and relapse prevention. Recovery
- 3 involves the development of a new meaning, purpose, and growing
- 4 beyond the impact of addiction or a diagnosis. Recovery may include
- 5 the pursuit of spiritual, emotional, mental, or physical well-
- 6 being.
- 7 (15) "Regional entity" means an entity established under
- 8 section 204b to provide specialty services and supports.
- 9 (16) "Rehabilitation" means the act of restoring an individual
- 10 to a state of mental and physical health or useful activity through
- 11 vocational or educational training, therapy, and counseling.
- 12 (17) "Resident" means an individual who receives services in a
- 13 facility.
- 14 (18) "Responsible mental health agency" means the hospital,
- 15 center, or community mental health services program that has
- 16 primary responsibility for the recipient's care or for the delivery
- 17 of services or supports to that recipient.
- 18 (19) "Rule" means a rule promulgated under the administrative
- 19 procedures act of 1969, 1969 PA 306, MCL 24.201 to 24.328.
- 20 Sec. 100d. (1) "Service" means a mental health service OR A
- 21 SUBSTANCE USE DISORDER SERVICE.
- 22 (2) "Serious emotional disturbance" means a diagnosable
- 23 mental, behavioral, or emotional disorder affecting a minor that
- 24 exists or has existed during the past year for a period of time
- 25 sufficient to meet diagnostic criteria specified in the most recent
- 26 diagnostic and statistical manual of mental disorders published by
- 27 the American psychiatric association and approved by the department

- 1 and that has resulted in functional impairment that substantially
- 2 interferes with or limits the minor's role or functioning in
- 3 family, school, or community activities. The following disorders
- 4 are included only if they occur in conjunction with another
- 5 diagnosable serious emotional disturbance:
- 6 (a) A substance use disorder.
- 7 (b) A developmental disorder.
- 8 (c) "V" codes in the diagnostic and statistical manual of
- 9 mental disorders.
- 10 (3) "Serious mental illness" means a diagnosable mental,
- 11 behavioral, or emotional disorder affecting an adult that exists or
- 12 has existed within the past year for a period of time sufficient to
- 13 meet diagnostic criteria specified in the most recent diagnostic
- 14 and statistical manual of mental disorders published by the
- 15 American psychiatric association and approved by the department and
- 16 that has resulted in functional impairment that substantially
- 17 interferes with or limits 1 or more major life activities. Serious
- 18 mental illness includes dementia with delusions, dementia with
- 19 depressed mood, and dementia with behavioral disturbance but does
- 20 not include any other dementia unless the dementia occurs in
- 21 conjunction with another diagnosable serious mental illness. The
- 22 following disorders also are included only if they occur in
- 23 conjunction with another diagnosable serious mental illness:
- 24 (a) A substance use disorder.
- 25 (b) A developmental disorder.
- 26 (c) A "V" code in the diagnostic and statistical manual of
- 27 mental disorders.

- 1 (4) "Special compensation" means payment to an adult foster
- 2 care facility to ensure the provision of a specialized program in
- 3 addition to the basic payment for adult foster care. Special
- 4 compensation does not include payment received directly from the
- 5 medicaid program for personal care services for a resident, or
- 6 payment received under the supplemental security income program.
- 7 (5) "Specialized program" means a program of services,
- 8 supports, or treatment that are provided in an adult foster care
- 9 facility to meet the unique programmatic needs of individuals with
- 10 serious mental illness or developmental disability as set forth in
- 11 the resident's individual plan of services and for which the adult
- 12 foster care facility receives special compensation.
- 13 (6) "Specialized residential service" means a combination of
- 14 residential care and mental health services that are expressly
- 15 designed to provide rehabilitation and therapy to a recipient, that
- 16 are provided in the residence of the recipient, and that are part
- 17 of a comprehensive individual plan of services.
- 18 (7) "State administered funds" means revenues appropriated by
- 19 the state—legislature exclusively for the purposes provided for in
- 20 regard to substance use disorder services and prevention.
- 21 (8) "State facility" means a center or a hospital operated by
- 22 the department.
- 23 (9) "State recipient rights advisory committee" means a
- 24 committee appointed by the director under section 756 to advise the
- 25 director and the director of the department's office of recipient
- 26 rights.
- 27 (10) "Substance abuse" means the taking of alcohol or other

- 1 drugs at dosages that place an individual's social, economic,
- 2 psychological, and physical welfare in potential hazard or to the
- 3 extent that an individual loses the power of self-control as a
- 4 result of the use of alcohol or drugs, or while habitually under
- 5 the influence of alcohol or drugs, endangers public health, morals,
- 6 safety, or welfare, or a combination thereof.
- 7 (11) "Substance use disorder" means chronic disorder in which
- 8 repeated use of alcohol, drugs, or both, results in significant and
- 9 adverse consequences. Substance abuse is considered a substance—use
- 10 disorder INCLUDES SUBSTANCE ABUSE.
- 11 (12) "Substance use disorder prevention services" means
- 12 services that are intended to reduce the consequences of substance
- 13 use disorders in communities by preventing or delaying the onset of
- 14 substance abuse and that are intended to reduce the progression of
- 15 substance use disorders in individuals. Substance use disorder
- 16 prevention is an ordered set of steps that promotes individual,
- 17 family, and community health, prevents mental and behavioral
- 18 disorders, supports resilience and recovery, and reinforces
- 19 treatment principles to prevent relapse.
- 20 (13) "Substance use disorder treatment and rehabilitation
- 21 services" means the providing of identifiable recovery-oriented
- 22 services including:
- (a) Early intervention and crisis intervention counseling
- 24 services for individuals who are current or former individuals with
- 25 substance use disorder.
- 26 (b) Referral services for individuals with substance use
- 27 disorder, their families, and the general public.

- 1 (c) Planned treatment services, including chemotherapy,
- 2 counseling, or rehabilitation for individuals physiologically or
- 3 psychologically dependent upon or abusing alcohol or drugs.
- 4 (14) "Supplemental security income" means the program
- 5 authorized under title XVI of the social security act, 42 USC 1381
- 6 to 1383f.
- 7 (15) "Transfer facility" means a facility selected by the
- 8 department-designated community mental health entity, which
- 9 facility is physically located in a jail or lockup and is staffed
- 10 by at least 1 designated representative when in use according to
- 11 chapter 2A.
- 12 (16) "Transition services" means a coordinated set of
- 13 activities for a special education student designed within an
- 14 outcome-oriented process that promotes movement from school to
- 15 postschool activities, including postsecondary education,
- 16 vocational training, integrated employment including supported
- 17 employment, continuing and adult education, adult services,
- 18 independent living, or community participation.
- 19 (17) "Treatment" means care, diagnostic, and therapeutic
- 20 services, including the administration of drugs, and any other
- 21 service for the treatment of an individual's serious mental
- 22 illness, or serious emotional disturbance, OR SUBSTANCE USE
- 23 DISORDER.
- 24 (18) "Treatment position" means a unit of measure of the
- 25 client capacity of a psychiatric partial hospitalization program.
- 26 Each treatment position represents a minimum of 6 hours per day and
- 5 days per calendar week.

- 1 (19) "Urgent situation" means a situation in which an
- 2 individual is determined to be at risk of experiencing an emergency
- 3 situation in the near future if he or she does not receive care,
- 4 treatment, or support services.
- 5 (20) "Wraparound services" means an individually designed set
- 6 of services provided to minors with serious emotional disturbance
- 7 or serious mental illness and their families that includes
- 8 treatment services and personal support services or any other
- 9 supports necessary to foster education preparedness, employability,
- 10 and preservation of the child in the family home. Wraparound
- 11 services are to be developed through an interagency collaborative
- 12 approach and a minor's parent or guardian and a minor age 14 or
- 13 older are to participate in planning the services.
- 14 Sec. 260. (1) As used in this chapter:
- 15 (A) "CHILD" MEANS AN INDIVIDUAL LESS THAN 14 YEARS OF AGE.
- 16 (B) (a) "Court" means the probate court for the county in

- 18 disorder treatment and rehabilitation services has been made OR A

- 26 (D) "HOSPITAL" MEANS A HOSPITAL LICENSED UNDER PART 215 OF THE
- 27 PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.21501 TO 333.21571.

- 1 (E) (b) "Minor" means an individual 14 or more years of age
- 2 and less than 18 years of age.
- **3 (F)** "Person in loco parentis" means an individual who is
- 4 not the parent or guardian of a child or minor but who has legal
- 5 custody of the child or minor and is providing support and care for
- 6 the child or minor.
- 7 (G) "PETITIONER" MEANS A PERSON THAT INSTITUTES A PROCEEDING
- 8 UNDER SECTION 281A.
- 9 (H) (d)—"Physiological dependency" means addiction to alcohol
- 10 or drugs that alters the body's physical or psychological status,
- 11 or both.
- 12 (I) (e) "Program" means a hospital, clinic, organization, or
- 13 health professional licensed under part 62 of the public health
- 14 code, 1978 PA 368, MCL 333.6230 to 333.6251, to provide treatment
- 15 services or screening and assessment SUBSTANCE USE DISORDER
- 16 services.
- 17 (J) "RESPONDENT" MEANS AN INDIVIDUAL ALLEGED IN A PETITION
- 18 FILED UNDER SECTION 281A TO BE AN INDIVIDUAL WHO HAS A SUBSTANCE
- 19 USE DISORDER AND WHO MAY BE ORDERED UNDER SECTION 281B OR 281C TO
- 20 UNDERGO INVOLUNTARY TREATMENT.
- 21 (2) The department shall begin implementation of the changes
- 22 in MADE TO this chapter BY 2012 PA 500 not later than October 1,
- 23 2013 and shall have the changes completed by not later than October

- 25 Sec. 276. (1) An individual who appears to be incapacitated in
- 26 a public place shall be taken into protective custody by a law
- 27 enforcement PEACE officer and taken to an approved service program

- 1 or to an emergency medical service, or to a transfer facility
- 2 according to subsection (4) for subsequent transportation to an
- 3 approved service program or emergency medical service. When EXCEPT

- 4 SEC. 281C. (1) FOLLOWING AN EXAMINATION BY A HEALTH
- 5 PROFESSIONAL UNDER SECTION 281B AND A CERTIFICATION BY THAT HEALTH
- 6 PROFESSIONAL THAT THE REQUIREMENTS OF SECTION 281A(1) ARE MET, A
- 7 COURT MAY ORDER THE RESPONDENT HELD FOR TREATMENT FOR A PERIOD NOT
