

SENATE SUBSTITUTE FOR  
HOUSE BILL NO. 5218

A bill to amend 1974 PA 381, entitled

"An act to encourage and contribute to the rehabilitation of former offenders and to assist them in the assumption of the responsibilities of citizenship; to prescribe the use of the term "good moral character" or similar term as a requirement for an occupational or professional license or when used as a requirement to establish or operate an organization or facility regulated by this state; and to provide administrative and judicial procedures to contest licensing board or agency rulings thereon,"

by amending section 2 (MCL 338.42).

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 2. (1) A judgment of guilt in a criminal prosecution or a  
2 judgment in a civil action shall not be used, in and of itself, by  
3 a licensing board or agency as proof of ~~a person's~~ **AN INDIVIDUAL'S**  
4 lack of good moral character. ~~It may be used~~ **HOWEVER, THE LICENSING**  
5 **BOARD OR AGENCY MAY USE THAT JUDGMENT** as evidence in the  
6 determination ~~, and when so used the person shall be notified and~~  
7 ~~shall be~~ **OF HIS OR HER GOOD MORAL CHARACTER.**

1           (2) IF A JUDGMENT OF GUILT IN A CRIMINAL PROSECUTION IS USED  
2 AS EVIDENCE IN THE DETERMINATION OF AN INDIVIDUAL'S GOOD MORAL  
3 CHARACTER UNDER SUBSECTION (1), THE LICENSING BOARD OR AGENCY SHALL  
4 ALSO CONSIDER HIS OR HER CERTIFICATE OF EMPLOYABILITY, IF ANY,  
5 UNDER SECTION 34D OF THE CORRECTIONS CODE OF 1953, 1953 PA 232, MCL  
6 791.234D, AS EVIDENCE IN THE DETERMINATION.

7           (3) IF A JUDGMENT OF GUILT IN A CRIMINAL PROCEEDING OR A  
8 JUDGMENT IN A CIVIL ACTION IS USED UNDER SUBSECTION (1) AS EVIDENCE  
9 OF AN INDIVIDUAL'S LACK OF GOOD MORAL CHARACTER, THE LICENSING  
10 BOARD OR AGENCY SHALL NOTIFY THE INDIVIDUAL AND HE OR SHE IS  
11 permitted to rebut the evidence by showing that at the current time  
12 he or she has the ability to, and is likely to, serve the public in  
13 a fair, honest, and open manner, that he or she is rehabilitated,  
14 or that the substance of the former offense is not reasonably  
15 related to the occupation or profession for which he or she ~~seeks~~  
16 ~~to be licensed.~~ **IS SEEKING A LICENSE.**

17           Enacting section 1. This amendatory act takes effect January  
18 1, 2015.

19           Enacting section 2. This amendatory act does not take effect  
20 unless all of the following bills of the 97th Legislature are  
21 enacted into law:
