HOUSE SUBSTITUTE FOR SENATE BILL NO. 1072

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

- 9 (e) The relevant department may review a previously unreviewed
- 10 aquatic species petitioned for listing as a permitted species under
- 11 section 41302a(5) for which the risk assessment process under
- 12 section 41302a(2) or (3) indicated a high invasive species risk.
- (C) (f) The relevant department may review other aquatic
- 14 species for listing as prohibited or restricted species.
- 15 (5) The relevant director may issue an emergency order
- 16 designating an organism as a prohibited species or restricted
- 17 species if the organism has the potential to harm human health or
- 18 to severely harm natural, agriculture, or silvicultural resources.
- 19 An emergency order is effective for not longer than 90 days OR A
- 20 SHORTER PERIOD IF SPECIFIED IN THE ORDER. The relevant department

- 22 (a) Post a proposed emergency order on its website and
- 23 otherwise publicize the proposed emergency order in a manner that
- 24 ensures that interested persons are provided notice of the proposed

- (b) Provide a copy of the proposed emergency order to each

- 5 (c) Post the final emergency order on its website.
- **6** (6) The relevant department may issue an order setting forth
- 7 the conditions under which naturalized organisms of an aquatic
