SENATE SUBSTITUTE FOR HOUSE BILL NO. 5195

A bill to amend 1949 PA 300, entitled

"Michigan vehicle code,"

by amending section 809 (MCL 257.809), as amended by 2019 PA 88.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 809. (1) An applicant for transfer of registration from a 1 2 vehicle subject to section 801(1)(a) to another vehicle subject to 3 that section shall accompany the application with a fee of \$8.00. In addition to the fee of \$8.00, if the registration is transferred 4 from a passenger vehicle to a motor home and if the registration 5 6 fee for the motor home is greater than the fee paid upon 7 registration of the vehicle from which the registration was removed, then the applicant shall pay the difference in fee. If the 8 fee is less than that paid for the registration of the vehicle from 9





which the plates were removed, the secretary of state shall not 1 refund the difference. The fees required by this subsection include 2 all fees or charges imposed by this act for the transfer of 3 registration, except those that may be assessed under section 234. 4 5 (2) An applicant for a to transfer of the registration - other 6 than a transfer described in subsection (1), from a vehicle subject 7 to section 801 to another vehicle subject to that section shall 8 accompany the application with a transfer of registration fee of 9 \$8.00. In addition to the fee of \$8.00, if \$10.00. If the

10 registration plates are transferred to another vehicle, as provided 11 in section 233, and if the registration plate fee for a 12-month registration for the vehicle to which the registration is 12 transferred is greater than the registration plate fee paid upon 13 14 registration of the vehicle from which the registration was 15 removed, then, the applicant shall pay the difference for the new registration. if applicable, in addition to the transfer of 16 17 registration fee of \$10.00, the secretary of state shall collect 1 18 of the registration difference fees as follows:

(a) If the application for transfer of registration is
accompanied by an application for a vehicle title indicating a
transfer of vehicle ownership and the application for vehicle title
indicates the vehicle ownership transfer is not exempt from use tax
collection under section 3(3)(a) or 4bb of the use tax act, 1937 PA
MCL 205.93 and 205.94bb, then \$5.00 shall be collected.

(b) If the vehicle to which the registration is being
transferred has never previously been registered and the
application for the last title issued was accompanied by a
manufacturer certificate of origin, then \$5.00 shall be collected.
(c) If the application for transfer of registration is not

accompanied by an application for a vehicle title indicating a
 transfer of ownership, then the difference for the new registration
 shall be collected.

4 (2) If the registration plate fee for a 12-month registration 5 for the vehicle to which the registration is transferred is less 6 than that the registration plate fee paid for upon registration of 7 the vehicle from which the registration was removed, the secretary 8 of state shall collect a transfer of registration fee of \$10.00 and 9 a registration difference fee of \$5.00 and shall not refund the 10 difference.

(3) Until October 1, 2023, a transfer of registration fee
collected under this section must be deposited into the
transportation administration collection fund created under section
810b.

15 Enacting section 1. This amendatory act takes effect 90 days 16 after the date it is enacted into law.

17 Enacting section 2. This amendatory act does not take effect18 unless House Bill No. 5313 of the 100th Legislature is enacted into19 law.
