

**SUBSTITUTE FOR  
HOUSE BILL NO. 5043**

A bill to create family child care networks; to prescribe the powers and duties of state departments and agencies; and to provide resources to child care providers.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 1. This act may be cited as the "family child care  
2 networks act".

3           Sec. 3. As used in this act:

4           (a) "Department" means the department of education.

5           (b) "Family child care network" or "network" means the  
6 networks created under section 5.

7           (c) "Provider" means a home-based group child care home or  
8 family child care home licensed under 1973 PA 116, MCL 722.111 to  
9 722.128.



1 (d) "Region" means 1 of at least 4 areas of the state as  
2 determined by the department to provide technical assistance to  
3 child care providers.

4 Sec. 5. (1) Upon appropriation, the department shall establish  
5 the family child care networks to support home-based child care  
6 providers. Funding must be dispersed equitably in a manner  
7 determined by the department with family child care networks in  
8 every region in this state.

9 (2) The department shall convene stakeholders to develop a  
10 framework for family child care networks based on the needs of  
11 providers. The framework must include, at least, the following:

- 12 (a) Business supports.
- 13 (b) Connections to peers.
- 14 (c) Operational supports.
- 15 (d) Program quality support.
- 16 (e) Training and technical assistance.
- 17 (f) Engaging new providers.

18 Sec. 10. A family child care network must offer or connect  
19 providers to services including, but not limited to, all of the  
20 following:

- 21 (a) Individual coaching.
- 22 (b) Training and professional development, including  
23 supporting developmental screenings, health and nutrition, program  
24 quality, and early childhood mental health consultation.
- 25 (c) Connections to peers.
- 26 (d) Operational supports, including assistance with licensing,  
27 subsidy billing, and recruiting families.
- 28 (e) Business services, including tax preparation, policies and  
29 procedures, and human resources support.



1           Sec. 15. (1) The department shall do, at a minimum, all of the  
2 following:

3           (a) Upon appropriation, establish a family child care network  
4 in every region of this state.

5           (b) Require all networks to participate in the following:

6           (i) A statewide community of practice.

7           (ii) Professional development for network staff.

8           (iii) Data collection and evaluation to measure success and  
9 improve the networks' responsiveness to providers.

10          (c) Require networks to be connected to the state's existing  
11 child care infrastructure, including, at least, the state's quality  
12 and licensing system.

13          (2) The department shall submit an annual report on the  
14 activities and outcomes of each family child care network by region  
15 and the changes in the number of home-based providers in the state  
16 to the house and senate appropriation committees on the department  
17 budget and the state budget office.
