SUBSTITUTE FOR SENATE BILL NO. 490

A bill to amend 1978 PA 454, entitled "Truth in renting act,"

(MCL 554.631 to 554.641) by adding section 4a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4a. (1) All of the following apply to a lease or a rental agreement under the mobile home commission act, 1987 PA 96, MCL
- 3 125.2301 to 125.2350:
- 4 (a) An owner of a mobile home park or seasonal mobile home
- 5 park shall offer a lease or rental agreement with a term of no less
- 6 than 1 year to a prospective tenant or tenant. However, nothing in
- 7 this subdivision prohibits an owner of a mobile home park or
- 8 seasonal mobile home park from entering into a monthly lease or
- 9 rental agreement with a prospective tenant or tenant, if the tenant





- 1 or prospective tenant declined a lease with a longer term.
- 2 (b) Not less than 30 days before a lease or a rental agreement
- 3 with a duration of 1 year or greater expires, the owner of a mobile
- 4 home park or seasonal mobile home park shall deliver to the tenant
- 5 a written or electronic notice identifying the date the lease or
- 6 rental agreement ends and offering a renewal of the lease or a new
- 7 lease or rental agreement. Any expired lease or rental agreement
- 8 not renewed in writing constitutes a month-to-month tenancy with
- 9 all the rights, responsibilities, and obligations of a month-to-
- 10 month tenancy. This subdivision is subject to the rights and
- 11 responsibilities of an owner of a mobile home park or seasonal
- 12 mobile home park to terminate a lease or rental agreement for just
- 13 cause under section 5775 of the revised judicature act of 1961,
- 14 1961 PA 236, MCL 600.5775.
- 15 (c) A lease or rental agreement between an owner of a mobile
- 16 home park or seasonal mobile home park and a tenant for a duration
- 17 that is less than 1 year must include language that a lease or
- 18 rental agreement of a duration of 1 year or more was offered but
- 19 was declined.
- 20 (d) A lease or rental agreement between an owner of a mobile
- 21 home park or seasonal mobile home park and a tenant must include
- 22 language that an unlicensed owner of a mobile home park or seasonal
- 23 mobile home park shall not do either of the following:
- 24 (i) Collect rent or take any action for possession against
- 25 residents.

- 26 (ii) Hold the tenant responsible for rent arrears incurred
- 27 during any period of time that the owner of a mobile home park or
- 28 seasonal mobile home park is unlicensed.

- 2 125.2301 to 125.2350, must comply with the requirements of this
