

HOUSE BILL No. 4340

February 7, 1995, Introduced by Rep. Kilpatrick and referred to the Committee on Regulatory Affairs.

A bill to amend Act No. 299 of the Public Acts of 1980, entitled as amended

"Occupational code,"

as amended, being sections 339.101 to 339.2721 of the Michigan Compiled Laws, by adding article 28.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 299 of the Public Acts of 1980, as
- 2 amended, being sections 339.10! to 339.272! of the Michigan
- 3 Compiled Laws, is amended by adding article 28 to read as
- 4 follows:
- 5 ARTICLE 28
- 6 SEC. 2801. AS USED IN THIS ARTICLE:
- 7 (A) "APPRENTICE" MEANS A PERSON ENGAGED IN LEARNING NATURAL
- 8 HAIR CULTIVATION IN A NATURAL HAIR CULTURE SALON.

- 1 (B) "BRAIDING" MEANS PROVIDING OR OFFERING TO THE GENERAL
- 2 PUBLIC FOR COMPENSATION ANY OF THE FOLLOWING SERVICES SOLELY FOR
- 3 DEVELOPMENT OR IMPROVEMENT OF PHYSICAL QUALITIES OF THE NATURAL
- 4 HAIR STRUCTURE:
- 5 (i) INTERTWINING IN A SYSTEMATIC MOTION TO CREATE PATTERNS
- 6 IN A 3-DIMENSIONAL FORM.
- 7 (ii) INVERSION OR OUTVERSION FLAT AGAINST THE SCALP ALONG
- 8 THE PART OF A STRAIGHT OR CURVED ROW.
- 9 (iii) TWISTING IN A SYSTEMATIC MOTION.
- 10 (iv) EXTENSION WITH NATURAL OR SYNTHETIC FIBERS.
- 11 (C) "INSTRUCTOR" MEANS A NATURAL HAIR CULTURIST WHO TEACHES
- 12 IN A SCHOOL OF NATURAL HAIR CULTIVATION ACCREDITED BY THE
- 13 DEPARTMENT.
- 14 (D) "MANAGING NATURAL HAIR CULTURIST" MEANS A PERSON IN
- 15 CHARGE OF AND UNDER WHOSE SUPERVISION A SCHOOL OF NATURAL HAIR
- 16 CULTIVATION OR NATURAL HAIR CULTURE SALON IS OPERATED.
- 17 (E) "NATURAL HAIR CULTIVATION" MEANS TECHNIQUES WHICH RESULT
- 18 IN TENSION ON HAIR STRANDS SUCH AS TWISTING, WRAPPING, WEAVING,
- 19 EXTENDING, LOCKING, OR BRAIDING OF THE HAIR BY HAND, WHICH WORK
- 20 DOES NOT INCLUDE THE APPLICATION OF DYES, REACTIVE CHEMICALS, OR
- 21 OTHER PREPARATIONS TO ALTER THE COLOR OR TO STRAIGHTEN, CURL, OR
- 22 ALTER THE STRUCTURE OF THE HAIR.
- 23 (F) "NATURAL HAIR CULTURE SALON" OR "SCHOOL OF NATURAL HAIR
- 24 CULTIVATION" IS A BUILDING, OR PART OF A BUILDING, COMPLETELY
- 25 PARTITIONED OFF FROM ANY OTHER BUSINESS OR DWELLING, EXCEPT A
- 26 BARBERSHOP LICENSED UNDER ARTICLE | 1 OR COSMETOLOGICAL

- 1 ESTABLISHMENT LICENSED UNDER ARTICLE 12, AT WHICH NATURAL HAIR
- 2 CULTIVATION IS PRACTICED OR TAUGHT FOR HIRE OR COMPENSATION.
- 3 (G) "NATURAL HAIR CULTURIST" MEANS A PERSON WHO ENGAGES IN
- 4 NATURAL HAIR CULTIVATION TECHNIQUES.
- 5 (H) "OWNER" MEANS A PERSON WHO OWNS A NATURAL HAIR CULTURE
- 6 SALON OR A SCHOOL OF NATURAL HAIR CULTIVATION.
- 7 (I) "STUDENT" MEANS A PERSON AT LEAST 17 YEARS OF AGE
- 8 ENGAGED IN LEARNING NATURAL HAIR CULTIVATION IN A SCHOOL OF NATU-
- 9 RAL HAIR CULTIVATION. THE MINIMUM AGE REQUIREMENT DOES NOT APPLY
- 10 TO A STUDENT ENROLLED IN A PROGRAM OFFERED AS A PART OF THE REGU-
- 11 LAR CURRICULUM OF A PUBLIC SCHOOL AND APPROVED BY THE STATE BOARD
- 12 OF EDUCATION.
- 13 SEC. 2803. A BOARD OF NATURAL HAIR CULTIVATION IS CREATED.
- 14 TWO OF THE MEMBERS OF THE BOARD SHALL BE LICENSED NATURAL HAIR
- 15 CULTURISTS WHO HAVE BEEN ACTIVELY ENGAGED IN THE PRACTICE OF NAT-
- 16 URAL HAIR CULTIVATION FOR AT LEAST 3 YEARS IMMEDIATELY PRECEDING
- 17 THEIR APPOINTMENT. ONE MEMBER SHALL BE A PERSON WHO HAS BEEN
- 18 ACTIVELY ENGAGED IN TEACHING NATURAL HAIR CULTIVATION IN THIS
- 19 STATE FOR NOT LESS THAN 3 YEARS IMMEDIATELY BEFORE APPOINTMENT.
- 20 ONE MEMBER SHALL BE A PERSON WHO OWNS AN INTEREST IN A SCHOOL OF
- 21 NATURAL HAIR CULTIVATION AND 1 MEMBER SHALL BE A PERSON WHO OWNS
- 22 AN INTEREST IN A NATURAL HAIR CULTURE SALON FOR NOT LESS THAN 1
- 23 YEAR IMMEDIATELY PRECEDING APPOINTMENT.
- 24 SEC. 2805. (1) A PERSON SHALL NOT RENDER ANY FORM OF NATU-
- 25 RAL HAIR CULTIVATION, WITH OR WITHOUT COMPENSATION, ON ANY PERSON
- 26 OTHER THAN A MEMBER OF HIS OR HER IMMEDIATE FAMILY UNLESS
- ?7 LICENSED UNDER THIS ARTICLE. THIS ARTICLE DOES NOT PROHIBIT A

- 1 PERSON FROM RENDERING SERVICES FOR WHICH HE OR SHE IS LICENSED
- 2 UNDER ARTICLES 11 OR 12.
- 3 (2) THE DEPARTMENT AND THE BOARD SHALL PROMULGATE RULES
- 4 INVOLVING THE SANITARY PRACTICE OF NATURAL HAIR CULTIVATION AS IT
- 5 CONSIDERS NECESSARY, WITH PARTICULAR REFERENCE TO THE PRECAUTIONS
- 6 NECESSARY TO BE EMPLOYED TO PREVENT THE SPREADING OF AN INFEC-
- 7 TIOUS OR CONTAGIOUS DISEASE AND TO PROVIDE FOR INSPECTIONS AS IT
- 8 CONSIDERS NECESSARY TO SAFEGUARD THE PUBLIC HEALTH.
- 9 SEC. 2807. A PERSON DESIRING TO OPERATE A NATURAL HAIR CUL-
- 10 TURE SALON SHALL APPLY TO THE DEPARTMENT FOR A LICENSE. THE NAT-
- 11 URAL HAIR CULTURE SALON SHALL BE UNDER THE DAILY ATTENDANCE AND
- 12 SUPERVISION OF A LICENSED NATURAL HAIR CULTURIST WHO IS NOT LESS
- 13 THAN 18 YEARS OF AGE AND HAS HAD NOT LESS THAN 1 YEAR OF PRACTI-
- 14 CAL EXPERIENCE IN NATURAL HAIR CULTIVATION. A NATURAL HAIR CUL-
- 15 TURE SALON SHALL NOT HAVE MORE THAN 2 APPRENTICES AT THE SAME
- 16 TIME. A NATURAL HAIR CULTURE SALON SHALL BE COMPLETELY SEPARATED
- 17 BY FULL PARTITIONS AND DOORS FROM EVERY OTHER ACTIVITY, BUSINESS,
- 18 OR DWELLING, EXCEPT A BARBERSHOP LICENSED UNDER ARTICLE 11 OR
- 19 COSMETOLOGICAL ESTABLISHMENT LICENSED UNDER ARTICLE 12 OR AN AREA
- 20 IN WHICH THE SALE OF CLOTHING AND ACCESSORIES IS CONDUCTED. THE
- 21 TRANSFER OF OWNERSHIP OR LOCATION OF A NATURAL HAIR CULTURE SALON
- 22 SHALL OPERATE TO AUTOMATICALLY REVOKE ITS LICENSE. A NEW LICENSE
- 23 SHALL NOT BE GRANTED TO A NEW OWNER OR AT A NEW LOCATION UNLESS
- 24 THE REQUIREMENTS OF THIS SECTION HAVE BEEN FULFILLED.
- 25 SEC. 2809. (1) THE DEPARTMENT SHALL ISSUE A LICENSE AS AN
- 26 INSTRUCTOR TO AN INDIVIDUAL WHO FULFILLS ALL OF THE FOLLOWING
- 27 REQUIREMENTS:

- 1 (A) IS AT LEAST 17 YEARS OF AGE.
- 2 (B) IS A LICENSED NATURAL HAIR CULTURIST.
- 3 (C) EXCEPT AS PROVIDED IN SUBSECTION (2), HAS COMPLETED 300
- 4 HOURS OF INSTRUCTION IN THE TEACHING OF NATURAL HAIR CULTIVATION
- 5 AT A LICENSED SCHOOL OF NATURAL HAIR CULTIVATION.
- 6 (D) HAS GRADUATED FROM HIGH SCHOOL OR HAS AN EQUIVALENT EDU-
- 7 CATION AS APPROVED BY THE DEPARTMENT.
- 8 (E) HAS PASSED AN EXAMINATION APPROVED BY THE BOARD AND THE
- 9 DEPARTMENT TO DETERMINE THE INDIVIDUAL'S FITNESS TO PRACTICE AS
- 10 AN INSTRUCTOR.
- 11 (F) IS OF GOOD MORAL CHARACTER.
- 12 (2) FOR THE PURPOSES OF FULFILLING THE REQUIREMENTS OF SUB-
- 13 SECTION (1)(C), AN INDIVIDUAL WHO HAS BEEN REGULATED UNDER THE
- 14 LAWS OF ANOTHER STATE, JURISDICTION, OR COUNTRY TO INSTRUCT
- 15 OTHERS IN NATURAL HAIR CULTIVATION MAY SUBSTITUTE 1 YEAR OF
- 16 EXPERIENCE IN NATURAL HAIR CULTIVATION INSTRUCTION FOR THE
- 17 REQUIRED TRAINING. THE REQUIREMENTS OF SUBSECTION (1)(B) AND (E)
- 18 SHALL NOT BE WAIVED ON THE BASIS OF PRIOR EXPERIENCE AS AN
- 19 INSTRUCTOR, EXCEPT AS OTHERWISE PROVIDED IN THIS ARTICLE.
- 20 SEC. 2811. (1) A PERSON DESIRING TO CONDUCT A SCHOOL OF
- 21 NATURAL HAIR CULTIVATION SHALL APPLY TO THE DEPARTMENT FOR A
- 22 LICENSE. A SCHOOL OF NATURAL HAIR CULTIVATION SHALL BE COM-
- 23 PLETELY SEPARATED BY A FULL PARTITION AND DOOR FROM EVERY OTHER
- 24 ACTIVITY, BUSINESS, OR DWELLING.
- 25 (2) A SCHOOL OF NATURAL HAIR CULTIVATION SHALL BE IN THE
- 26 CHARGE OF AND UNDER THE SUPERVISION AND DAILY ATTENDANCE OF A
- 27 MANAGING NATURAL HAIR CULTURIST WHO MEETS ALL OF THE FOLLOWING:

- 1 (A) IS LICENSED AS AN INSTRUCTOR WHO HAS HAD AT LEAST 3
- 2 YEARS OF PRACTICAL EXPERIENCE IN NATURAL HAIR CULTIVATION IN A
- 3 LICENSED NATURAL HAIR CULTURE SALON OR AT LEAST 1 YEAR OF PRACTI-
- 4 CAL EXPERIENCE IN NATURAL HAIR CULTIVATION IN A LICENSED NATURAL
- 5 HAIR CULTURE SALON AND AT LEAST 2 YEARS OF PRACTICAL EXPERIENCE
- 6 IN TEACHING NATURAL HAIR CULTIVATION.
- 7 (B) IS A LICENSED NATURAL HAIR CULTURIST WITH NOT LESS THAN
- 8 300 HOURS OF INSTRUCTOR TRAINING.
- 9 (C) HAS A HIGH SCHOOL DIPLOMA OR ITS EQUIVALENT.
- (D) HAS PASSED AN EXAMINATION APPROVED BY THE DEPARTMENT AND 11 THE BOARD.
- 12 (E) IS OF GOOD MORAL CHARACTER.
- 13 (3) A SCHOOL OF NATURAL HAIR CULTIVATION SHALL FULFILL ALL
- 14 OF THE FOLLOWING REQUIREMENTS:
- 15 (A) SHALL MAINTAIN A SCHOOL TERM OF NOT LESS THAN 400 HOURS,
- 16 EXTENDING OVER A PERIOD OF 3 CONSECUTIVE MONTHS, AND SHALL MAIN-
- 17 TAIN A COURSE OF PRACTICAL TRAINING AND TECHNICAL INSTRUCTION, AS
- 18 OUTLINED IN THE DEPARTMENT-APPROVED CURRICULUM, EQUAL TO THE
- 19 REQUIREMENTS FOR EXAMINATION FOR A LICENSE AS A NATURAL HAIR
- 20 CULTURIST AS SET FORTH IN SECTION 2815.
- 21 (B) SHALL POSSESS EFFICIENT APPARATUS AND EQUIPMENT PRE-
- 22 SCRIBED BY THE DEPARTMENT AND THE BOARD SUFFICIENT FOR THE READY
- 23 AND FULL TEACHING OF EACH SUBJECT IN THE CURRICULUM APPROVED BY
- 24 THE DEPARTMENT AND THE BOARD.
- 25 (C) SHALL MAINTAIN | PERSON LICENSED AS AN INSTRUCTOR FOR
- 26 EVERY 20 ENROLLED STUDENTS. THE INSTRUCTOR SHALL NOT BE IN

- 1 CHARGE OF OR SUPERVISE A SCHOOL UNLESS THE INSTRUCTOR MEETS THE
- 2 EXPERIENCE REQUIREMENT DESCRIBED IN THIS SECTION.
- 3 (D) SHALL KEEP A DAILY RECORD OF THE ATTENDANCE OF EACH STU-
- 4 DENT, A COPY OF WHICH SHALL BE SENT TO THE DEPARTMENT MONTHLY,
- 5 ESTABLISH GRADES, AND HOLD AN EXAMINATION APPROVED BY THE BOARD
- 6 BEFORE ISSUING A DIPLOMA.
- 7 (E) SHALL BE OPERATED FOR TEACHING PURPOSES ONLY AND A STU-
- 8 DENT SHALL NOT PRACTICE ON THE PUBLIC UNTIL HAVING COMPLETED AT
- 9 LEAST 75 HOURS OF INSTRUCTION IN THE NATURAL HAIR CULTIVATION
- 10 CURRICULUM.
- 11 (F) PROVIDE THAT A STUDENT NOT BE IN ATTENDANCE AT THE
- 12 SCHOOL MORE THAN 7 HOURS PER DAY OR MORE THAN 40 HOURS PER WEEK.
- 13 (4) A SCHOOL OF NATURAL HAIR CULTIVATION SHALL FURNISH A
- 14 BOND OF \$10,000.00 IN FAVOR OF THE PEOPLE OF THE STATE FOR THE
- 15 USE AND BENEFIT OF STUDENTS AND CONDITIONED UPON THE FAITHFUL
- 16 PERFORMANCE AND SATISFACTION OF THE CONTRACTUAL RIGHTS OF
- 17 STUDENTS.
- 18 (5) A SCHOOL OF NATURAL HAIR CULTIVATION AT THE TIME OF THE
- 19 ENROLLMENT OF A STUDENT SHALL FURNISH THE STUDENT A FINANCIAL
- 20 CONTRACT SHOWING THE TOTAL COST AND ALL CHARGES INVOLVED IN THE
- 21 COMPLETE COURSE OF STUDY. ADVERTISING MATTER PUT OUT BY SCHOOLS,
- 22 WHEN MENTIONING THE COST OF TUITION OR RELATED SUBJECTS, SHALL
- 23 FURNISH THE SAME FINANCIAL STATEMENT AS DESCRIBED IN THIS
- 24 SUBSECTION.
- 25 (6) A NATURAL HAIR CULTURE SALON EXACTING A FEE FOR THE
- 26 TEACHING OF NATURAL HAIR CULTIVATION IS CONSIDERED A SCHOOL OF

- 1 NATURAL HAIR CULTIVATION AND IS REQUIRED TO COMPLY WITH THIS
- 2 SECTION.
- 3 (7) THE TRANSFER OF OWNERSHIP OR LOCATION OF A SCHOOL OF
- 4 NATURAL HAIR CULTIVATION SHALL OPERATE TO AUTOMATICALLY REVOKE
- 5 ITS LICENSE. A NEW LICENSE SHALL NOT BE GRANTED TO NEW OWNERS OR
- 6 FOR A NEW LOCATION UNLESS THE REQUIREMENTS OF THIS SECTION ARE
- 7 FULFILLED.
- 8 SEC. 2813. AN OWNER OF OR PERSON IN CHARGE OF A NATURAL
- 9 HAIR CULTURE SALON OR SCHOOL OF NATURAL HAIR CULTIVATION SHALL
- 10 NOT PERMIT A PERSON TO SLEEP IN OR USE FOR RESIDENTIAL PURPOSES A
- 11 ROOM USED, WHOLLY OR IN PART, FOR A SCHOOL OF NATURAL HAIR CULTI-
- 12 VATION OR A NATURAL HAIR CULTURE SALON.
- 13 SEC. 2815. THE DEPARTMENT SHALL ISSUE A LICENSE TO PRACTICE
- 14 NATURAL HAIR CULTIVATION TO AN INDIVIDUAL WHO FULFILLS ALL OF THE
- 15 FOLLOWING REQUIREMENTS:
- 16 (A) PASSES AN EXAMINATION PRESCRIBED BY THE DEPARTMENT AND
- 17 THE BOARD, WHICH EXAMINATION SHALL INCLUDE BOTH A PRACTICAL
- 18 DEMONSTRATION AND A WRITTEN OR ORAL TEST AND SHALL NOT BE CON-
- 19 FINED TO A SPECIFIC SYSTEM OR METHOD.
- 20 (B) PRESENTS A DIPLOMA, ISSUED TO THE APPLICANT BY A SCHOOL
- 21 OF NATURAL HAIR CULTIVATION LICENSED BY THE DEPARTMENT, SHOWING
- 22 THAT THE APPLICANT HAS COMPLETED THE COURSE OF STUDY IN THE
- 23 SCHOOL PRESCRIBED BY THE DEPARTMENT, OR FURNISHES PROOF OF HAVING
- 24 COMPLETED THE REQUIRED TIME IN A LICENSED SCHOOL OF NATURAL HAIR
- 25 CULTIVATION AS PRESCRIBED BY THE DEPARTMENT.
- 26 (C) IS AT LEAST 17 YEARS OF AGE.

- 1 (D) IS OF GOOD MORAL CHARACTER.
- 2 (E) HAS AN EDUCATION EQUIVALENT TO THE COMPLETION OF THE 3 NINTH GRADE OF PUBLIC SCHOOL.
- 4 (F) HAS TRAINING OF AT LEAST 400 HOURS EXTENDING OVER A
- 5 PERIOD OF AT LEAST 3 MONTHS IN A SCHOOL OF NATURAL HAIR CULTIVA-
- 6 TION APPROVED BY THE DEPARTMENT, OR HAS SERVED AT LEAST ! YEAR AS
- 7 AN APPRENTICE IN A LICENSED NATURAL HAIR CULTURE SALON IN WHICH
- 8 NATURAL HAIR CULTIVATION IS PRACTICED.
- 9 SEC. 2817. AN APPLICATION FOR ADMISSION TO EXAMINATION AND
- 10 AN APPLICATION FOR LICENSURE AS A NATURAL HAIR CULTURIST SHALL BE
- 11 IN WRITING ON A FORM PREPARED AND FURNISHED BY THE DEPARTMENT.
- 12 AN APPLICATION SHALL CONTAIN PROOF OF THE QUALIFICATIONS OF THE
- 13 APPLICANT FOR EXAMINATION AS PROVIDED IN THIS ARTICLE AND SHALL
- 14 BE VERIFIED BY THE OATH OF THE APPLICANT.
- 15 SEC. 2819. UPON AN APPLICATION TO THE DEPARTMENT, AN INDI-
- 16 VIDUAL LICENSED AS A NATURAL HAIR CULTURIST UNDER THE LAWS OF
- 17 ANOTHER STATE SHALL, WITHOUT EXAMINATION, BE GRANTED A LICENSE TO
- 18 PRACTICE THE OCCUPATION IN WHICH THAT INDIVIDUAL IS LICENSED IF
- 19 THE APPLICANT IS NOT LESS THAN 17 YEARS OF AGE, IS OF GOOD MORAL
- 20 CHARACTER, AND THE REQUIREMENTS FOR REGISTRATION OR LICENSURE AS
- 21 A NATURAL HAIR CULTURIST IN THE PARTICULAR STATE ARE SUBSTAN-
- 22 TIALLY EQUAL TO THE CURRENT REQUIREMENTS OF THIS STATE. YEARS OR
- 23 MONTHS OF EXPERIENCE AS A LICENSED NATURAL HAIR CULTURIST MAY BE
- 24 SUBSTITUTED FOR HOURS OF TRAINING IN A RATIO OF 100 HOURS OF
- 25 TRAINING CREDITED FOR EACH 6 MONTHS OF EXPERIENCE. AN INDIVIDUAL
- 26 APPLYING FOR LICENSURE HAVING QUALIFICATIONS ACQUIRED OUTSIDE OF
- 27 THE UNITED STATES SHALL PROVIDE PROOF OF TRAINING OR EXPERIENCE,

- 1 OR BOTH. AS A NATURAL HAIR CULTURIST. THE DEPARTMENT SHALL
- 2 DETERMINE WHETHER SUCH AN APPLICANT IS QUALIFIED TO BE ADMITTED
- 3 FOR EXAMINATION FOR LICENSURE.
- 4 SEC. 2821. THE DEPARTMENT AND THE BOARD SHALL WAIVE THE
- 5 EXAMINATION REQUIREMENT OF SECTIONS 2809 AND 2815 FOR ANY APPLI-
- 6 CANT FOR LICENSURE AS AN INSTRUCTOR OR NATURAL HAIR CULTURIST WHO
- 7 PRESENTS EVIDENCE SATISFACTORY TO THE BOARD AND THE DEPARTMENT
- 8 THAT THE APPLICANT MEETS THE QUALIFICATIONS REQUIRED BY SECTIONS
- 9 2809 AND 2815 AND HAS BEEN EMPLOYED IN THE PRACTICE OF NATURAL
- 10 HAIR CULTIVATION ON A FULL-TIME BASIS FOR AT LEAST 3 OF THE LAST
- 11 5 YEARS IMMEDIATELY PRECEDING THE EFFECTIVE DATE OF THIS ARTICLE,
- 12 IF THE APPLICATION FOR THE WAIVER IS MADE WITHIN 12 MONTHS AFTER
- 13 THE EFFECTIVE DATE OF THIS ARTICLE.
- 14 SEC. 2823. A SCHOOL OF NATURAL HAIR CULTIVATION OR A NATU-
- 15 RAL HAIR CULTURE SALON, UPON ENROLLING A STUDENT OR APPRENTICE,
- 16 SHALL FILE AN APPLICATION WITH THE DEPARTMENT AND SHALL OBTAIN
- 17 PROOF FROM THE STUDENT OF AT LEAST A NINTH GRADE EDUCATION OR THE
- 18 EQUIVALENT OF A NINTH GRADE EDUCATION. THE APPLICATION AND PROOF
- 19 OF EDUCATION SHALL BE KEPT ON FILE UNTIL THE STUDENT OR APPREN-
- 20 TICE APPLIES FOR AN EXAMINATION AS A NATURAL HAIR CULTURIST. THE
- 21 NINTH GRADE EDUCATION REQUIREMENT SHALL NOT APPLY TO A STUDENT
- 22 ENROLLING IN A PROGRAM OFFERED AS A PART OF THE REGULAR CURRICU-
