A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding section 21055a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 21055a to read as
- 4 follows:
- 5 SEC. 21055A. (1) EXCEPT FOR A HOSPITAL OR PROVIDER THAT HAS
- 6 A CONTRACTUAL RELATIONSHIP WITH A HEALTH MAINTENANCE ORGANIZA-
- 7 TION, A HEALTH MAINTENANCE ORGANIZATION THAT GENERATES A PAPER
- 8 BILLING SHALL REQUIRE THE USE OF A STANDARD MEDICAL CLAIM FORM
- 9 THAT MAY BE PROVIDER SPECIFIC ESTABLISHED BY THE COMMISSIONER
