A bill to amend Act No. 451 of the Public Acts of 1976, entitled as amended

"The school code of 1976,"

as amended, being sections 380.1 to 380.1852 of the Michigan Compiled Laws, by adding section 1230b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 451 of the Public Acts of 1976, as
- 2 amended, being sections 380.1 to 380.1852 of the Michigan
- 3 Compiled Laws, is amended by adding section 1230b to read as
- 4 follows:
- 5 SEC. 1230B. (1) A SCHOOL DISTRICT, LOCAL ACT SCHOOL DIS-
- 6 TRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL DISTRICT, OR
- 7 NONPUBLIC SCHOOL SHALL REQUEST AN APPLICANT FOR EMPLOYMENT TO
- 8 SIGN A STATEMENT THAT AUTHORIZES THE APPLICANT'S CURRENT OR
- 9 FORMER EMPLOYER OR EMPLOYERS TO DISCLOSE TO THE SCHOOL DISTRICT,

- 1 LOCAL ACT SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE
- 2 SCHOOL DISTRICT, OR NONPUBLIC SCHOOL ANY UNPROFESSIONAL CONDUCT
- 3 BY THE APPLICANT THAT INVOLVED ANOTHER PERSON AND THAT RESULTED
- 4 IN SEPARATION FROM EMPLOYMENT, AND TO MAKE AVAILABLE TO THE
- 5 SCHOOL DISTRICT, LOCAL ACT SCHOOL DISTRICT, PUBLIC SCHOOL ACADE-
- 6 MY, INTERMEDIATE SCHOOL DISTRICT, OR NONPUBLIC SCHOOL ALL OF THE
- 7 CURRENT OR FORMER EMPLOYER'S RECORDS RELATING TO THAT UNPROFES-
- 8 SIONAL CONDUCT OR TO THE APPLICANT'S SEPARATION FROM EMPLOYMENT
- 9 WITH THAT EMPLOYER, AND THAT RELEASES THE CURRENT OR FORMER
- 10 EMPLOYER FROM ANY LIABILITY FOR PROVIDING THAT INFORMATION. THE
- 11 BOARD OR GOVERNING BODY OF A SCHOOL DISTRICT, LOCAL ACT SCHOOL
- 12 DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL DISTRICT, OR
- 13 NONPUBLIC SCHOOL SHALL NOT HIRE AN APPLICANT WHO DOES NOT SIGN
- 14 THE STATEMENT DESCRIBED IN THIS SUBSECTION.
- 15 (2) IN THE PROCESS OF HIRING AN APPLICANT FOR EMPLOYMENT WHO
- 16 HAS SIGNED THE STATEMENT DESCRIBED IN SUBSECTION (1), THE BOARD
- 17 OR GOVERNING BODY OF A SCHOOL DISTRICT, LOCAL ACT SCHOOL DIS-
- 18 TRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL DISTRICT, OR
- 19 NONPUBLIC SCHOOL SHALL REQUEST AT LEAST THE APPLICANT'S CURRENT
- 20 EMPLOYER OR, IF THE APPLICANT IS NOT CURRENTLY EMPLOYED, THE
- 21 APPLICANT'S IMMEDIATELY PREVIOUS EMPLOYER TO PROVIDE THE INFORMA-
- 22 TION DESCRIBED IN SUBSECTION (1), IF ANY.
- 23 (3) INFORMATION RECEIVED UNDER SUBSECTION (2) SHALL BE USED
- 24 BY A SCHOOL DISTRICT, LOCAL ACT SCHOOL DISTRICT, PUBLIC SCHOOL
- 25 ACADEMY, INTERMEDIATE SCHOOL DISTRICT, OR NONPUBLIC SCHOOL ONLY
- 26 FOR THE PURPOSE OF EVALUATING AN APPLICANT'S QUALIFICATIONS FOR
- 27 EMPLOYMENT IN THE POSITION FOR WHICH HE OR SHE HAS APPLIED.

- 1 EXCEPT AS OTHERWISE PROVIDED BY LAW, A BOARD MEMBER OR EMPLOYEE
- 2 OF A SCHOOL DISTRICT, LOCAL ACT SCHOOL DISTRICT, PUBLIC SCHOOL
- 3 ACADEMY, INTERMEDIATE SCHOOL DISTRICT, OR NONPUBLIC SCHOOL SHALL
- 4 NOT DISCLOSE THE INFORMATION TO ANY PERSON WHO IS NOT DIRECTLY
- 5 INVOLVED IN EVALUATING THE APPLICANT'S QUALIFICATIONS FOR
- 6 EMPLOYMENT. A PERSON WHO VIOLATES THIS SUBSECTION IS GUILTY OF A
- 7 MISDEMEANOR PUNISHABLE BY A FINE OF NOT MORE THAN \$10,000.00, BUT
- 8 IS NOT SUBJECT TO THE PENALTIES UNDER SECTION 1804.
- 9 (4) THE BOARD OR AN OFFICIAL OF A SCHOOL DISTRICT, LOCAL ACT
- 10 SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL DIS-
- 11 TRICT, OR NONPUBLIC SCHOOL SHALL NOT ENTER INTO ANY AGREEMENT
- 12 WITH AN EMPLOYEE OR FORMER EMPLOYEE THAT HAS THE EFFECT OF SUP-
- 13 PRESSING INFORMATION ABOUT UNPROFESSIONAL CONDUCT OF THE EMPLOYEE
- 14 OR FORMER EMPLOYEE THAT INVOLVED ANOTHER PERSON AND THAT RESULTED
- 15 IN SEPARATION FROM EMPLOYMENT.
- 16 (5) THIS SECTION DOES NOT PREVENT A SCHOOL DISTRICT, LOCAL
- 17 ACT SCHOOL DISTRICT, PUBLIC SCHOOL ACADEMY, INTERMEDIATE SCHOOL
- 18 DISTRICT, OR NONPUBLIC SCHOOL FROM REQUESTING OR REQUIRING AN
- 19 APPLICANT FOR EMPLOYMENT TO PROVIDE INFORMATION OTHER THAN THAT
- 20 DESCRIBED IN THIS SECTION.
