

HOUSE BILL No. 6019

September 10, 1996, Introduced by Rep. Dolan and referred to the Committee on Regulatory Affairs.

A bill to amend Act No. 8 of the Public Acts of the Extra Session of 1933, entitled as amended
"The Michigan liquor control act,"
as amended, being sections 436.1 to 436.58 of the Michigan
Compiled Laws, by adding section 33d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Section 1. Act No. 8 of the Public Acts of the Extra
- 2 Session of 1933, as amended, being sections 436.1 to 436.58 of
- 3 the Michigan Compiled Laws, is amended by adding section 33d to
- 4 read as follows:
- 5 SEC. 33D. (1) EXCEPT AS OTHERWISE PROVIDED IN SUBSECTION
- 6 (2), A PARENT, GUARDIAN, PERSON CHARGED WITH THE RESPONSIBILITY
- 7 OR CUSTODY, OR PERSON IN LOCO PARENTIS OF A PERSON LESS THAN 21
- 8 YEARS OF AGE SHALL NOT KNOWINGLY ALLOW THE PERSON LESS THAN 21
- 9 YEARS OF AGE TO BE WITHIN 10 FEET OR LESS OF A BAR.

- (2) THIS SECTION DOES NOT APPLY TO EITHER OF THE FOLLOWING:
- (A) THE PRESENCE OF A PERSON LESS THAN 21 YEARS OF AGE
- 3 WITHIN 10 FEET OF A BAR IF ALCOHOLIC LIQUOR IS NOT BEING SERVED
- 4 AT THE BAR.
- (B) SERVICE OF ALCOHOLIC LIQUOR AT A TABLE OR BOOTH IN AN
- 6 ESTABLISHMENT LICENSED FOR CONSUMPTION OF ALCOHOLIC LIQUOR ON THE
- 7 LICENSED PREMISES.
- (3) A SUITABLE SIGN DESCRIBING THE CONTENT OF THIS SECTION
- 9 AND THE PENALTIES FOR ITS VIOLATION SHALL BE POSTED IN A CONSPIC-
- 10 UOUS PLACE IN EACH ROOM WHERE A BAR IS LOCATED. THE SIGN SHALL
- II BE APPROVED AND FURNISHED BY THE COMMISSION.
- 12 (4) A PERSON FOUND GUILTY OF VIOLATING THIS SECTION SHALL BE
- 13 PUNISHED IN THE MANNER PROVIDED FOR IN SECTION 50.
