

SENATE BILL No. 665

September 20, 1995, Introduced by Senator HONIGMAN and referred to the Committee on Economic Development, International Trade and Regulatory Affairs.

A bill to amend Act No. 368 of the Public Acts of 1978, entitled as amended

"Public health code,"

as amended, being sections 333.1101 to 333.25211 of the Michigan Compiled Laws, by adding section 16281.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Section 1. Act No. 368 of the Public Acts of 1978, as
- 2 amended, being sections 333.1101 to 333.25211 of the Michigan
- 3 Compiled Laws, is amended by adding section 16281 to read as
- 4 follows:
- 5 SEC. 16281. (1) A LICENSEE OR REGISTRANT WHO HAS REASONABLE
- 6 CAUSE TO BELIEVE THAT AN INDIVIDUAL BEING TREATED BY THE LICENSEE
- 7 OR REGISTRANT IS AFFLICTED WITH A MENTAL OR PHYSICAL INFIRMITY OR
- 8 DISABILITY RENDERING IT UNSAFE FOR THAT INDIVIDUAL TO DRIVE A

- 12 (A) "MOTOR VEHICLE" MEANS THAT TERM AS DEFINED IN SECTION 33
- 13 OF THE MICHIGAN VEHICLE CODE, ACT NO. 300 OF THE PUBLIC ACTS OF
- 14 1949, BEING SECTION 257.33 OF THE MICHIGAN COMPILED LAWS.
- 15 (B) "PHYSICIAN" MEANS THAT TERM AS DEFINED IN SECTIONS 17001
- 16 AND 17501.
