- 3 SHALL ISSUE A MICHIGAN ARTS LOVER PLATE TO AN APPLICANT FOR USE
- 4 ON THE PASSENGER MOTOR VEHICLE, PICKUP TRUCK, VAN, OR MOTOR HOME
- 5 FOR WHICH THE REGISTRATION PLATE IS ISSUED INSTEAD OF A STANDARD
- 6 REGISTRATION PLATE.
- 7 (2) AN APPLICATION FOR A MICHIGAN ARTS LOVER REGISTRATION
- 8 PLATE SHALL BE SUBMITTED TO THE SECRETARY OF STATE PURSUANT TO
- 9 THE PROCEDURES PRESCRIBED IN SECTION 217.
