

HOUSE BILL No. 4025

January 8, 1997, Introduced by Rep. Ciaramitaro and referred to the Committee on Consumer Protection.

A bill to amend 1846 RS 14, entitled
"Of county officers,"
(MCL 55.107 to 55.117) by adding section 112a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 112A. (1) A NOTARY PUBLIC MAY USE A NOTARY FORM SET
2 FORTH IN THIS SECTION. A NOTARY FORM SET FORTH IN THIS SECTION
3 SHALL BE KNOWN AS PLAIN ENGLISH NOTARY FORM AND MAY BE REFERRED
4 TO BY THAT NAME. A NOTARY FORM SET FORTH IN THIS SECTION THAT IS
5 PROPERLY EXECUTED IS SUFFICIENT TO ACCOMPLISH ITS STATED PURPOSE
6 UNDER THE LAW OF THIS STATE. THIS SECTION DOES NOT PRECLUDE THE
7 USE OF OTHER NOTARY FORMS.

8 (2) AN AFFIDAVIT OR SWORN STATEMENT MAY BE SUBSTANTIALLY IN
9 THE FOLLOWING FORM:
