- 1 PART 429. NATIVE CATS, BEARS, AND WOLVES IN CAPTIVITY
- 2 SEC. 42901. AS USED IN THIS PART:
- 3 (A) "DEPARTMENT" MEANS THE DIRECTOR OF THE DEPARTMENT OF
- 4 NATURAL RESOURCES OR HIS OR HER DESIGNEE TO WHOM THE DIRECTOR
- 5 DELEGATES A POWER OR DUTY BY WRITTEN INSTRUMENT.
- 6 (B) "DANGEROUS WILD ANIMAL" MEANS ANY OF THE FOLLOWING:
- 7 (i) A CAT OF THE FELIDAE FAMILY OF A SPECIES THAT IS NATIVE
- 8 TO THIS STATE, WHETHER WILD OR CAPTIVE BRED, INCLUDING A HYBRID
- 9 CROSS WITH SUCH A CAT.
- 10 (ii) A BEAR OF A SPECIES THAT IS NATIVE TO THIS STATE,
- 11 WHETHER WILD OR CAPTIVE BRED.
