- 4 POLICY AND CERTIFICATE COVERAGE FOR MEDICALLY RECOGNIZED DIAGNOS-
- 5 TIC SCREENING FOR PROSTATIC CANCER AS FOLLOWS:
- 6 (A) IF RECOMMENDED BY A PHYSICIAN, AT ANY AGE FOR MEN WITH A
- 7 PRIOR HISTORY OF PROSTATE CANCER.
- 8 (B) ANNUALLY FOR THE FOLLOWING:
- 9 (i) FIFTY OR OLDER ASYMPTOMATIC MEN.
- 10 (ii) FORTY OR OLDER AFRICAN-AMERICAN MEN.
