November 10, 1998, Introduced by Rep. Alley and referred to the Committee on Conservation, Environment and Recreation.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 8807 (MCL 324.8807), as added by 1998 PA 287, and by adding section 8807a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 8807. (1) The clean water fund is created within the
- 2 state treasury.
- **3** (2) The state treasurer may receive money or other assets
- 4 from any source for deposit into the fund. The state treasurer
- 5 shall direct the investment of the fund. The state treasurer
- 6 shall credit to the fund interest and earnings from fund
- 7 investments.

- 23 FOR A "CLEAN LAKES PROGRAM". FUNDS FROM THE CLEAN LAKES PROGRAM

- 8 DITIONAL WASTEWATER TREATMENT TECHNOLOGIES.
- 9 (E) UP TO \$10,000,000.00 FOR CLOSING ABANDONED WELLS WITH
- 10 PRIORITY GIVEN TO WELLS IN WELLHEAD PROTECTION AREAS WHOSE CLO-
- 11 SURE IS INCLUDED IN APPROVED WELLHEAD PROTECTION PLANS.
- 12 (F) UP TO \$5,000,000.00 FOR THE EXTENSION OF MUNICIPAL SEWER
- 13 SYSTEMS TO REPLACE SEPTIC TANKS IN AREAS WHERE CLUSTERS OF FAIL-
- 14 ING TANKS HAVE BEEN DETERMINED TO CONTRIBUTE TO WATER QUALITY
- 15 IMPAIRMENTS, PROVIDED THAT THE AREAS TO RECEIVE SEWER EXTENSIONS
- 16 ARE ALREADY INTENSIVELY DEVELOPED.
- 17 (5) Money in the fund shall not be expended for combined
- 18 sewer overflow corrections.
- 19 (6) The first priority for expenditure of money in the fund
- 20 shall be for the programs described in subsection (4)(a).
- 21 (6) $\overline{(7)}$ Money in the fund shall not be expended until
- 22 rules are promulgated under section 8808.
