## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 57K. (1) THE DEPARTMENT SHALL OPERATE A PROGRAM ALLOW ING AN INDIVIDUAL ELIGIBLE FOR FAMILY INDEPENDENCE ASSISTANCE TO
 ESTABLISH AN INDIVIDUAL DEVELOPMENT ACCOUNT FOR FIRST-TIME HOME BUYERS IN ACCORDANCE WITH THIS SECTION. THE DEPARTMENT SHALL
 DISREGARD FUNDS, INCLUDING ACCRUED INTEREST, IN AN INDIVIDUAL
 DEVELOPMENT ACCOUNT IN DETERMINING THE INDIVIDUAL'S ELIGIBILITY
 FOR FAMILY INDEPENDENCE ASSISTANCE AND THE AMOUNT OF THE GRANT
 THE INDIVIDUAL RECEIVES.

1 NOT MORE THAN \$4,000.00 FOR THE PURPOSE OF ACCUMULATING FUNDS FOR 2 A QUALIFIED PURPOSE DESCRIBED IN SUBSECTION (3). OR ORGANIZED IN THE UNITED STATES THAT IS FUNDED THROUGH PERIODIC
CONTRIBUTIONS BY THE ESTABLISHING INDIVIDUAL IN ACCORDANCE WITH
THIS SECTION AND THAT MAY BE MATCHED BY OR THROUGH A QUALIFIED
ENTITY FOR A QUALIFIED PURPOSE DESCRIBED IN SUBSECTION (3).
(C) "QUALIFIED ACQUISITION COSTS" MEANS THE COSTS OF
ACQUIRING, CONSTRUCTING, OR RECONSTRUCTING A QUALIFIED PRINCIPAL

1 RESIDENCE. THE TERM INCLUDES ANY USUAL OR REASONABLE SETTLEMENT, 2 FINANCING, OR OTHER CLOSING COSTS.

(D) "QUALIFIED ENTITY" MEANS EITHER OF THE FOLLOWING: 3 4 (*i*) A NOT-FOR-PROFIT ORGANIZATION DESCRIBED IN SECTION 5 501(c)(3) OF THE INTERNAL REVENUE CODE OF 1986 AND EXEMPT FROM 6 TAXATION UNDER SECTION 501(a) OF THAT CODE.

7 (*ii*) A STATE OR LOCAL GOVERNMENTAL AGENCY ACTING IN COOPERA-8 TION WITH AN ORGANIZATION DESCRIBED IN SUBPARAGRAPH (i).

(E) "OUALIFIED FIRST-TIME HOMEBUYER" MEANS A TAXPAYER AND, 9 10 IF MARRIED, THE TAXPAYER'S SPOUSE WHO HAS NO PRESENT OWNERSHIP 11 INTEREST IN A PRINCIPAL RESIDENCE DURING THE 3-YEAR PERIOD ENDING 12 ON THE DATE OF ACQUISITION OF THE QUALIFIED PRINCIPAL RESIDENCE 13 TO WHICH THIS SECTION APPLIES.

(F) "QUALIFIED PRINCIPAL RESIDENCE" MEANS A PRINCIPAL RESI-14 15 DENCE WITHIN THE MEANING OF SECTION 1034 OF THE INTERNAL REVENUE 16 CODE OF 1986, THE QUALIFIED ACQUISITION COSTS OF WHICH DO NOT 17 EXCEED 100% OF THE AVERAGE AREA PURCHASE PRICE APPLICABLE TO THAT 18 RESIDENCE, DETERMINED IN ACCORDANCE WITH PARAGRAPHS (2) AND (3) 19 OF SECTION 143(e) OF THE INTERNAL REVENUE CODE OF 1986.
