## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411R. (1) AN INDIVIDUAL WHO IS REQUIRED TO BE REGIS-
- 2 TERED UNDER SECTION 3 OF THE SEX OFFENDERS REGISTRATION ACT, 1994
- 3 PA 295, MCL 28.723, SHALL NOT DO EITHER OF THE FOLLOWING:
- 4 (A) LOITER ON SCHOOL PROPERTY OR IN A PUBLIC PARK OR WITHIN
- 5 1,000 FEET OF SCHOOL PROPERTY OR A PUBLIC PARK.
- 6 (B) RESIDE WITHIN 1,000 FEET OF SCHOOL PROPERTY OR A PUBLIC 7 PARK.
- 8 (2) AN INDIVIDUAL WHO VIOLATES THIS SECTION IS GUILTY OF A
- 9 FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A
- 10 FINE OF NOT MORE THAN \$2,000.00, OR BOTH.

- 8 IGNATED BY THIS STATE OR THAT POLITICAL SUBDIVISION AS A PARK.
- 9 (B) "SCHOOL PROPERTY" MEANS A BUILDING, PLAYING FIELD, OR
- 10 PROPERTY USED FOR SCHOOL PURPOSES TO IMPART INSTRUCTION TO CHIL-
- 11 DREN IN GRADES KINDERGARTEN THROUGH 12, WHEN PROVIDED BY A
- 12 PUBLIC, PRIVATE, DENOMINATIONAL, OR PAROCHIAL SCHOOL, EXCEPT
- 13 THOSE BUILDINGS USED PRIMARILY FOR ADULT EDUCATION OR COLLEGE
- 14 EXTENSION COURSES.
