House Bill No. 4284, entitled

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 658 (MCL 257.658), as amended by 1984 PA 328.

Was read a second time, and the question being on the adoption of the proposed amendment previously recommended by the Committee on Transportation (for amendment, see House Journal No. 58, p. 1343),

The amendment was adopted, a majority of the members serving voting therefor.

Rep. Basham moved to amend the bill as follows:

- 1. Amend page 1, following "THE PEOPLE OF THE STATE OF MICHIGAN ENACT:" by inserting:
- "Sec. 312b. (1) Before a A person who is less than 18 years of age is SHALL NOT BE issued an original motorcycle endorsement on an operator's or chauffeur's license; UNLESS the person shall pass PASSES an examination as required by this section and a motorcycle safety course as provided in section 811a or 811b.
- (2) Before a A person who is 18 years of age or older is SHALL NOT BE issued an original motorcycle endorsement on an operator's or chauffeur's license; UNLESS the person shall pass PASSES an examination as required by this section. A person who fails this examination 2 or more times is required to SHALL successfully complete a motorcycle safety course as provided in section 811a or 811b. Each written examination given an applicant for a motorcycle endorsement on an operator's or chauffeur's license as provided in section 309 shall also include subjects designed to cover a motorcycle. A person shall pass an examination that shall include INCLUDES a driving test designed to test the competency of the applicant for the first motorcycle endorsement on an operator's or chauffeur's license to operate a motorcycle upon the roads and highways of this state with safety to himself or herself and other persons and property. All examinations shall be administered as provided in this act. The requirement of a motorcycle driving test shall be waived for an applicant who has successfully completed a motorcycle safety course conducted by a school or business enterprise as provided in section 811a or 811b. The motorcycle safety course skills test shall meet or exceed the motorcycle skills test from the secretary of state. The requirement of a motorcycle driving test may be waived if the applicant has a valid license or endorsement to operate a motorcycle from another state.
- (3) A motorcycle endorsement issued to a person who operates a 3-wheeled motorcycle or an autocycle shall be restricted to operation of that type of motorcycle and does not permit operation of a 2-wheeled motorcycle. The secretary of state shall develop a driving test specifically pertaining to an autocycle or a 3-wheeled motorcycle.
- (4) The secretary of state is responsible for establishing and conducting the motorcycle operator driving test and shall promulgate rules under the administrative procedures act of 1969, Act No. 306 of the Public Acts of 1969, as amended, being sections 24.201 to 24.328 of the Michigan Compiled Laws 1969 PA 306, MCL 24.201 TO 24.328, for purposes of this subsection. An audit of the motorcycle safety fund shall be conducted in conjunction with the audit of school management services by the office of the auditor general to determine compliance with the requirement that funds are being withdrawn only in relation to this act and not costs that are already a function or duty of the education act. A copy of this audit shall be transmitted to the legislature upon completion.
- (5) The secretary of state shall charge a \$15.00 fee for each motorcycle operator driving test. The \$15.00 fee shall be placed in a motorcycle safety fund in the state treasury and shall be used to pay the costs the secretary of state incurs in conducting motorcycle operator driving tests as provided for under this section and section 811a.
- (6) Beginning not later than June 1, 1997, the secretary of state may enter into an agreement with another public or private person or agency to conduct a driving test required under this section. For administering and overseeing a third party motorcycle testing program, the secretary of state shall be reimbursed from the motorcycle safety fund a total amount which does not exceed 50% of the department's 1995-1996 fiscal year appropriation for motorcycle testing under this section.

- (7) A PERSON WHO APPLIES FOR A MOTORCYCLE ENDORSEMENT SHALL BE GIVEN AN OPPORTUNITY AT THE SECRETARY OF STATE BRANCH OFFICE WHERE HE OR SHE APPLIES FOR THE ENDORSEMENT TO VIEW A VIDEO CONCERNING CLOSED HEAD INJURIES. THE SECRETARY OF STATE MAY CHARGE THE APPLICANT A SEPARATE FEE THAT REFLECTS THE COST OF MAINTAINING AND SHOWING THE VIDEO. AN APPLICANT WHO IS OTHERWISE ELIGIBLE TO BE ISSUED A MOTORCYCLE ENDORSEMENT SHALL BE ISSUED AN ENDORSEMENT THAT INDICATES THAT HE OR SHE IS NOT REQUIRED TO WEAR A CRASH HELMET WHILE OPERATING A MOTORCYCLE IF HE OR SHE FIRST VIEWS THE VIDEO AND PAYS ANY VIDEO FEE. HOWEVER, AN APPLICANT WHO IS OTHERWISE ELIGIBLE TO BE ISSUED A MOTORCYCLE ENDORSEMENT WHO REFUSES TO VIEW THE VIDEO OR WHO REFUSES TO PAY ANY VIDEO FEE SHALL BE ISSUED A MOTORCYCLE ENDORSEMENT THAT INDICATES THAT HE OR SHE IS REQUIRED TO WEAR A HELMET WHILE OPERATING A MOTORCYCLE.".
- 2. Amend page 1, line 9, after "(4)" by striking out "A" and inserting "EXCEPT AS PROVIDED IN SUBSECTION (5), A".
 - 3. Amend page 1, line 9, after "person" by striking out "LESS THAN 21 YEARS OF AGE".
 - 4. Amend page 2, following line 12, by inserting:
- "(5) A PERSON WHO OPERATES OR RIDES ON A MOTORCYCLE SHALL WEAR A CRASH HELMET ON HIS OR HER HEAD UNLESS HE OR SHE DISPLAYS UPON DEMAND A MOTORCYCLE ENDORSEMENT INDICATING THAT HE OR SHE IS NOT REQUIRED TO WEAR A HELMET." and renumbering the remaining subsection.

The motion prevailed and the amendments were adopted, a majority of the members serving voting therefor.

Rep. Callahan moved to amend the bill as follows:

- 1. Amend page 2, following line 14, by inserting:
- "(6) A PERSON WHO IS 21 YEARS OF AGE OR OLDER WHO OWNS OR REGISTERS A MOTORCYCLE SHALL MAINTAIN THE SAME SECURITY FOR PAYMENT OF BENEFITS UNDER PERSONAL PROTECTION INSURANCE, PROPERTY PROTECTION INSURANCE, AND RESIDUAL LIABILITY INSURANCE AS IS REQUIRED FOR OWNERS AND REGISTRANTS OF MOTOR VEHICLES UNDER THE INSURANCE CODE OF 1956, 1956 PA 218, MCL 500.100 TO 500.8302.
- (7) AN OWNER OR REGISTRANT OF A MOTORCYCLE SHALL NOT OPERATE OR ALLOW ANOTHER PERSON TO OPERATE ON A HIGHWAY A MOTORCYCLE THAT HE OR SHE OWNS OR HAS REGISTERED THAT IS NOT INSURED AS REQUIRED UNDER SUBSECTION (6). A PERSON SHALL NOT OPERATE ON A HIGHWAY A MOTORCYCLE THAT HE OR SHE KNOWS IS NOT INSURED AS REQUIRED IN SUBSECTION (6). A PERSON WHO VIOLATES THIS SUBSECTION IS GUILTY OF A MISDEMEANOR AND SHALL BE FINED NOT MORE THAN \$1,000.00 AND SHALL HAVE 1 POINT ENTERED ON HIS OR HER DRIVING RECORD BY THE SECRETARY OF STATE.

A resolution to urge the Natural Resources Commission to establish a pilot project to permit deer hunting, including the hunting of antlerless deer, with a firearm from a raised platform.

Whereas, Changes in technology, Michigan's deer population, and other conditions have required wildlife management practices to remain flexible; and

Whereas, In recent years, Michigan's deer population has increased significantly in certain regions of the state. This has caused an increase in motor vehicle accidents involving deer and an increase in damage to crops and forest land; and

Whereas, To control the burgeoning deer population, the state has extended hunting seasons and sold additional hunting licenses, providing people with more opportunities to hunt; and

Whereas, Michigan is one of only two states that prohibit firearm deer hunting from raised platforms. Hunting from a raised platform is a legal and common practice in Michigan for those who hunt deer with bows. Allowing hunters to use this tool for firearm hunting and extending it to include antlerless deer will prove beneficial for both Michigan hunters and the state's effort to control the wildlife population; now, therefore, be it

Resolved by the House of Representatives, That we urge the Natural Resources Commission to undertake a pilot project to permit deer hunting with a firearm from a raised platform, including hunting for antlerless deer, as a further check on the deer population; and be it further

Resolved, That copies of this resolution be transmitted to the Natural Resources Commission.

A concurrent resolution to memorialize the Congress of the United States to amend the 1996 Illegal Immigration Reform and Immigrant Responsibility Act to ease requirements for Canadians and Americans crossing the border and to oppose the imposition of any fees in connection with border crossings.

Whereas, With the enactment of the 1996 Illegal Immigration Reform and Immigrant Responsibility Act, the Immigration and Naturalization Service must develop an automated entry and exit system to document the entry and departure of every alien visiting this country. While the aim of this legislation is to safeguard our borders from illegal entries, the act has great potential for harm at crossing sites with large numbers of daily visitors for work and recreation purposes; and

Whereas, The longstanding practice of permitting Canadian visitors to enter the United States without a passport, visa, or border crossing identification conflicts with provisions of the new law, especially section 110. For Americans leaving this country to visit Canada, there has been no requirement to stop to have the exit recorded. With the volume of border crossings in Michigan, especially Detroit, where the commercial, personal, and tourist crossings already make it the busiest point on the border, the impact of the new law will be very harmful; and

Whereas, The revamped immigration law is intended to focus on illegal immigrants, not the businessperson, the vacationing family, or the person crossing the border for an afternoon's entertainment. Clogging the crossing points with stopped traffic will also present serious obstacles to the movement of parts and equipment in a vital hub of industry. The aim of more trade between two partners in commerce would be jeopardized without a more realistic and practical approach to monitoring our border with Canada; now, therefore, be it

Resolved by the House of Representatives (the Senate concurring), That we memorialize the Congress of the United States to amend the 1996 Illegal Immigration Reform and Immigrant Responsibility Act to ease requirements for Canadians and Americans crossing the border and to oppose the imposition of any fees in connection with border crossings; and be it further
