Whereas, America has always been the beacon of hope for the ideals of liberty and religious freedom; now, therefore, be it

Resolved by the House of Representatives, That the members of the Michigan House of Representatives call on the citizens of this great state to observe November 16, 1997, as International Day of Prayer for the Persecuted Church; and be it further

Resolved, That copies of this resolution be transmitted to coordinators of this event.

Whereas, The recent Chinese and American summit has reminded the world of the persecution of the Tibetan Buddhist believers; and

Whereas, The suffering or death of any human, of any or no religious faith, is wrong before God; now, therefore, be it Resolved by the House of Representatives, That we memorialize the President and the United States Congress to exercise a stance of uncompromising opposition to religious persecution around the world; and be it further

Resolved, That a copy of this resolution be transmitted to the Office of the President of the United States, the President of the United States Senate, the Speaker of the United States House of Representatives, and the members of the Michigan congressional delegation.
