

SUBSTITUTE FOR
HOUSE BILL NO. 4825

A bill to amend 1913 PA 379, entitled

"An act to facilitate the collection of alimony and support and maintenance for minor children or for children who are 18 years of age or older ordered to be paid in suits for divorce or separate maintenance,"

by amending section 2 (MCL 552.152) and by adding section 6.

10 SUPPORT AND FEES THROUGH THE TRANSITION, BASED ON THE SCHEDULE
11 DEVELOPED AS REQUIRED BY SECTION 6 OF THE OFFICE OF CHILD SUPPORT
12 ACT, 1971 PA 174, MCL 400.236, AND MODIFICATIONS TO THAT SCHEDULE
13 AS THE DEPARTMENT CONSIDERS NECESSARY.

14 Enacting section 1. This amendatory act does not take
