

SUBSTITUTE FOR
HOUSE BILL NO. 4880

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
(MCL 750.1 to 750.568) by adding section 506c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 506C. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
2 ACT, THE COURT MAY ORDER AN INDIVIDUAL CONVICTED OF COMMITTING A
3 VIOLATION OF THIS ACT IN WHICH AN INDIVIDUAL 65 YEARS OF AGE OR
4 OLDER IS A VICTIM OF THAT VIOLATION TO PAY NOT MORE THAN TWICE
5 THE FINE OTHERWISE AUTHORIZED FOR THAT VIOLATION OR TO PAY A FINE
6 AUTHORIZED UNDER SUBSECTION (2).

7 (2) IF THE VIOLATION IS NOT OTHERWISE PUNISHABLE BY A FINE,
8 THE COURT, IN ADDITION TO ANY AUTHORIZED PENALTY, MAY ORDER THE
9 INDIVIDUAL TO PAY A FINE AS FOLLOWS:

10 (A) A FINE OF NOT MORE THAN \$200.00 IF THE VIOLATION IS A
11 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR LESS THAN 6 MONTHS.

1 (B) A FINE OF NOT MORE THAN \$500.00 IF THE VIOLATION IS A
2 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 6 MONTHS.

3 (C) A FINE OF NOT MORE THAN \$1,000.00 IF THE VIOLATION IS A
4 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 1 YEAR.

5 (D) A FINE OF NOT MORE THAN \$2,000.00 IF THE VIOLATION IS A
6 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR MORE THAN 1 YEAR BUT
7 NOT MORE THAN 2 YEARS OR IF THE VIOLATION IS A FELONY PUNISHABLE
8 BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS.

9 (E) A FINE OF NOT MORE THAN \$4,000.00 IF THE VIOLATION IS A
10 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 2 YEARS BUT NOT
11 MORE THAN 4 YEARS.

12 (F) A FINE OF NOT MORE THAN \$5,000.00 IF THE VIOLATION IS A
13 FELONY PUNISHABLE BY IMPRISONMENT FOR 5 YEARS.

14 (G) A FINE OF NOT MORE THAN \$10,000.00 IF THE VIOLATION IS A
15 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 5 YEARS.

16 (3) THIS SECTION APPLIES TO CRIMES COMMITTED ON OR AFTER THE
17 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
