- 1 Sec. 80163. (1) A PERSON SHALL NOT SET, PLACE, ERECT, OR
- 2 CAUSE TO BE SET, PLACED, OR ERECTED, OR USE AN ANCHORED RAFT AT
- 3 ANY TIME UPON THE WATERS OF WHICH THE STATE HAS JURISDICTION,
- 4 UNLESS THE NAME AND ADDRESS OF THE OWNER IS AFFIXED TO THE
- 5 ANCHORED RAFT ABOVE THE WATERLINE IN LEGIBLE LETTERS NOT LESS
- 6 THAN 2 INCHES IN HEIGHT. THE LETTERS SHALL BE READILY VISIBLE
- 7 AND CONSIST OF MATERIALS THAT ARE NOT SOLUBLE IN WATER.
- 8 (2) PLACING THE OWNER'S NAME AND ADDRESS ON A PIECE OF WOOD
- 9 AND AFFIXING THAT PIECE OF WOOD TO THE ANCHORED RAFT DOES NOT
- 10 CONSTITUTE COMPLIANCE WITH SUBSECTION (1).
