(2) ~~Except~~ SUBJECT TO SUBSECTION (3), EXCEPT as otherwise provided by an administrative rule in effect on October 1, 1988, or as otherwise provided by law, a certificate, permit, authorization, endorsement, or approval, and the renewal of a certificate, certificate reinstatement, or authorization issued pursuant to subsection (1) is valid for 5 years.

(3) NOTWITHSTANDING ANY RULE TO THE CONTRARY, A SUBSTITUTE TEACHER PERMIT IS VALID FOR 3 YEARS.
