A bill to amend 1981 PA 180, entitled "Older Michiganians act,"

(MCL 400.581 to 400.594) by adding section 13a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 13A. (1) THE SECRETARY OF STATE SHALL ESTABLISH A
- 2 MICHIGAN CARD PROGRAM AND PROVIDE A MICHIGAN CARD TO ANY RESIDENT
- 3 OF THIS STATE WHO APPLIES TO THE SECRETARY OF STATE FOR A CARD
- 4 AND WHO IS DISABLED OR IS 65 YEARS OF AGE OR OLDER. THE DIRECTOR
- 5 SHALL DEVISE PROGRAMS TO PROVIDE BENEFITS OF ANY KIND TO CARD-
- 6 HOLDERS AND ENCOURAGE SUPPORT AND PARTICIPATION IN THOSE PROGRAMS
- 7 BY ALL PERSONS, INCLUDING GOVERNMENTAL ORGANIZATIONS.
- 8 CARDHOLDERS ARE ENTITLED TO ANY BENEFITS GRANTED TO THEM BY PRI-
- 9 VATE PERSONS OR ORGANIZATIONS, THE LAWS OF THIS STATE, OR
- 10 ORDINANCES OR RESOLUTIONS OF POLITICAL SUBDIVISIONS OF THIS
- 11 STATE. A PERSON WHO IS THE HOLDER OF A SIMILAR CARD FROM ANOTHER

- 1 STATE IS ENTITLED TO THE SAME BENEFITS AS A CARDHOLDER WHOSE CARD
- 2 HAS BEEN ISSUED IN THIS STATE, IF THE OTHER STATE PROVIDES SIMI-
- 3 LAR BENEFITS TO THE HOLDERS OF CARDS ISSUED BY OTHER STATES.
- 4 THIS SECTION DOES NOT REQUIRE ANY PERSON OR ORGANIZATION TO PRO-
- 5 VIDE BENEFITS TO ANY CARDHOLDER. THE SECRETARY OF STATE SHALL

- 12 (3) THE DIRECTOR SHALL PROMULGATE RULES UNDER THE ADMINIS-
- 13 TRATIVE PROCEDURES ACT OF 1969, 1969 PA 306, MCL 24.201 TO
- 14 24.328, TO PREVENT THE ISSUANCE OF A CARD TO A PERSON NOT QUALI-
- 15 FIED TO HAVE ONE. A CARD SHALL CONTAIN THE SIGNATURE OF THE
- 16 CARDHOLDER AND ANY OTHER INFORMATION THAT THE SECRETARY OF STATE
- 17 CONSIDERS NECESSARY TO EFFECTUATE THE PURPOSES OF THIS SECTION.
- 18 (4) A CARD THAT THE DIRECTOR ISSUES SHALL BE HELD IN PERPE-
- 19 TUITY BY THE ORIGINAL CARDHOLDER AND IS NOT TRANSFERABLE. A
- 20 PERSON WHO LOSES HIS OR HER CARD MAY OBTAIN ANOTHER CARD FROM THE
- 21 SECRETARY OF STATE.
- (5) A PERSON SHALL NOT USE A MICHIGAN CARD TO OBTAIN A BENE-22
- 23 FIT FOR A PERSON OTHER THAN THE CARDHOLDER.
- (6) AS USED IN THIS SECTION, "DISABLED PERSON" MEANS A
- 25 PERSON WHO HAS A DISABILITY AS DEFINED IN SECTION 216 OF TITLE II
- 26 OF THE SOCIAL SECURITY ACT, 42 U.S.C. 416.
