THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1304. (1) NOT LATER THAN THE BEGINNING OF THE
- 2 2000-2001 SCHOOL YEAR, THE BOARD OF A SCHOOL DISTRICT, LOCAL ACT
- 3 SCHOOL DISTRICT, OR INTERMEDIATE SCHOOL DISTRICT OR THE BOARD OF
- 4 DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL ENSURE THAT EACH
- 5 CLASSROOM IN USE IN A SCHOOL UNDER ITS CONTROL IS EQUIPPED WITH A
- 6 TELEPHONE OR OTHER ELECTRONIC COMMUNICATIONS DEVICE THAT IS
- 7 DIRECTLY LINKED TO AN APPROPRIATE LAW ENFORCEMENT AGENCY AND FIRE
- 8 DEPARTMENT. THE BOARD OR BOARD OF DIRECTORS ALSO SHALL ENSURE
- 9 THAT TEACHERS AND OTHER APPROPRIATE PERSONNEL ARE TRAINED IN THE
- 10 PROPER USE OF THESE TELEPHONES OR COMMUNICATIONS DEVICES.

- 1 (2) A LAW ENFORCEMENT AGENCY OR FIRE DEPARTMENT SHALL
