HOUSE BILL NO. 5389

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 17 of chapter XVII (MCL 777.17), as amended
by 2001 PA 136, and by adding sections 17b, 17c, 17d, 17f, and
17g to chapter XVII.

CHAPTER XVII
