by amending section 302 (MCL 600.302), as amended by 1993 PA 190,  
and by adding section 302a.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1       Sec. 302. ~~For the election of judges, the~~ THE state is  
2 divided into 4 judicial districts FOR THE ELECTION OF JUDGES OF  
3 THE COURT OF APPEALS. Each district is entitled to ~~elect~~ 7  
4 judges. The districts are constituted and numbered as follows:  
5       (A) District 1 consists of the counties of ~~Wayne, Monroe,~~
