A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 1027 (MCL 436.2027) and by adding section 1016.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1016. (1) AN ON-PREMISES LICENSEE MAY OFFER AND AWARD
- 2 AN EMPLOYEE OF THE LICENSEE UNOPENED ALCOHOLIC LIQUOR IN A SEALED
- 3 CONTAINER AS A GIFT OR AS A PRIZE FOR ANY ACTIVITY ALLOWED UNDER
