THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1537. (1) THE TASK FORCE ON PARAPROFESSIONAL CERTIFI-
- 2 CATION IS CREATED AS A TEMPORARY COMMISSION DESCRIBED IN
- 3 SECTION 4 OF ARTICLE V OF THE STATE CONSTITUTION OF 1963. THE
- 4 TASK FORCE SHALL STUDY THE ISSUES SPECIFIED IN THIS SUBSECTION
- 5 CONCERNING THE CERTIFICATION OF PARAPROFESSIONALS WHO WORK WITH
- 6 PUPILS IN THE PUBLIC SCHOOLS AND MAKE RECOMMENDATIONS TO THE LEG-
- 7 ISLATURE NOT LATER THAN 1 YEAR AFTER THE EFFECTIVE DATE OF THIS

- 17 (C) ONE MEMBER REPRESENTING SCHOOL BOARDS, APPOINTED FROM
- 18 AMONG NOMINATIONS SUBMITTED BY THE MICHIGAN ASSOCIATION OF SCHOOL
- 19 BOARDS.
- 20 (D) ONE MEMBER REPRESENTING PUBLIC SCHOOL ADMINISTRATORS,
- 21 APPOINTED FROM AMONG NOMINATIONS SUBMITTED BY THE MICHIGAN ASSO-
- 22 CIATION OF SCHOOL ADMINISTRATORS.
- 23 (E) ONE MEMBER REPRESENTING PARENTS, APPOINTED FROM AMONG
- 24 NOMINATIONS SUBMITTED BY THE MICHIGAN PARENT TEACHER
- 25 ORGANIZATION.

- 1 (F) TWO MEMBERS REPRESENTING THE DEPARTMENT, WITH 1
- 2 REPRESENTING THE PROFESSIONAL DEVELOPMENT UNIT AND 1 REPRESENTING
- 3 THE SPECIAL EDUCATION UNIT.
- 4 (G) ONE MEMBER REPRESENTING INSTITUTIONS OF HIGHER
- 5 EDUCATION.
- 6 (3) THE MEMBERS APPOINTED TO THE TASK FORCE ON PARAPROFES-
- 7 SIONAL CERTIFICATION SHALL BE APPOINTED NOT LATER THAN 30 DAYS
- 8 AFTER THE EFFECTIVE DATE OF THIS SECTION.
- 9 (4) MEMBERS OF THE TASK FORCE ON PARAPROFESSIONAL CERTIFICA-
- 10 TION SHALL SERVE UNTIL THE TASK FORCE FINDINGS ARE REPORTED AS
- 11 REQUIRED UNDER SUBSECTION (1).
- 12 (5) IF A VACANCY OCCURS ON THE TASK FORCE ON PARAPROFES-
- 13 SIONAL CERTIFICATION, THE SUPERINTENDENT OF PUBLIC INSTRUCTION
- 14 SHALL APPOINT A REPLACEMENT IN THE SAME MANNER AS THE ORIGINAL
- **15** APPOINTMENT.
- 16 (6) THE FIRST MEETING OF THE TASK FORCE ON PARAPROFESSIONAL
- 17 CERTIFICATION SHALL BE CALLED BY THE SUPERINTENDENT OF PUBLIC
- 18 INSTRUCTION.
- 19 (7) A MAJORITY OF THE MEMBERS OF THE TASK FORCE ON PARAPRO-
- 20 FESSIONAL CERTIFICATION CONSTITUTE A QUORUM FOR THE TRANSACTION
- 21 OF BUSINESS AT A MEETING OF THE TASK FORCE. A MAJORITY OF THE

- 1 (9) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF,

- 3 IN THE PERFORMANCE OF AN OFFICIAL FUNCTION IS SUBJECT TO THE

- 5 (10) MEMBERS OF THE TASK FORCE ON PARAPROFESSIONAL CERTIFI-
- 6 CATION SHALL SERVE WITHOUT COMPENSATION. HOWEVER, MEMBERS OF THE
- 7 TASK FORCE MAY BE REIMBURSED IN ACCORDANCE WITH DEPARTMENT OF
- 8 MANAGEMENT AND BUDGET TRAVEL REIMBURSEMENT GUIDELINES FOR MILEAGE
- 9 EXPENSES INCURRED IN THE PERFORMANCE OF THEIR OFFICIAL DUTIES AS
- 10 MEMBERS OF THE TASK FORCE.
- 11 (11) THE DEPARTMENT SHALL PROVIDE STAFFING AND OTHER
- 12 RESOURCES FOR THE TASK FORCE ON PARAPROFESSIONAL CERTIFICATION AS
- 13 REASONABLY REQUESTED BY THE TASK FORCE.
- 14 (12) AS USED IN THIS SECTION, "PARAPROFESSIONAL" MEANS A
- 15 SCHOOL EMPLOYEE, OTHER THAN A TEACHER, WHO SERVES IN A POSITION
- 16 THAT IS EITHER INSTRUCTIONAL IN NATURE OR INVOLVES DELIVERY OF
- 17 OTHER DIRECT SERVICES TO PUPILS OR THEIR PARENTS AND FOR WHICH A
- 18 TEACHER OR OTHER PROFESSIONAL HAS THE ULTIMATE RESPONSIBILITY FOR
- 19 THE DESIGN, IMPLEMENTATION, AND EVALUATION OF INDIVIDUAL EDUCA-
- 20 TION PROGRAMS OR RELATED SERVICES AND FOR PUPIL PERFORMANCE.
