A bill to amend 1939 PA 280, entitled "The social welfare act," (MCL 400.1 to 400.119b) by adding section 106a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 106A. THE DEPARTMENT OF COMMUNITY HEALTH IS SUBROGATED
- 2 TO A RIGHT OF RECOVERY THAT A PATIENT HAS FOR THE COST OF HOSPI-
- 3 TALIZATION, PHARMACEUTICAL SERVICES, PHYSICIAN SERVICES, NURSING
- 4 SERVICES, AND OTHER MEDICAL SERVICES NOT TO EXCEED THE AMOUNT OF
- 5 MONEY EXPENDED BY THE DEPARTMENT OF COMMUNITY HEALTH FOR THE CARE
- 6 AND TREATMENT OF THE PATIENT. THE PATIENT OR OTHER PERSON ACTING
- 7 IN THE PATIENT'S BEHALF SHALL EXECUTE AND DELIVER AN ASSIGNMENT
- 8 OF CLAIM OR OTHER AUTHORIZATION AS NECESSARY TO SECURE THE RIGHT
- 9 OF RECOVERY TO THE DEPARTMENT. A PAYMENT MAY BE WITHHELD UNDER
- 10 THIS ACT FOR MEDICAL ASSISTANCE FOR AN INJURY OR DISABILITY FOR
- 11 WHICH THE PATIENT IS ENTITLED TO MEDICAL CARE OR REIMBURSEMENT
