- 4 HIGHWAY I-94 IN JACKSON COUNTY, THEN BEGINNING AT THE INTERSEC-
- 5 TION OF US-127 AND THE SOUTHERN BORDER OF INGHAM COUNTY AND CON-
- 6 TINUING THROUGH INGHAM COUNTY TO THE INTERSECTION OF HIGHWAY
- 7 US-127 AND THE BORDER BETWEEN INGHAM AND CLINTON COUNTIES, SHALL
- 8 BE CALLED THE "ANNIE OAKLEY MEMORIAL PIKE".
