THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 8316. (1) At the beginning of each school year, school administrators shall notify parents and guardians of children attending that school of the right to be informed prior to any application of a pesticide at that school.
 - (2) The notice described in subsection (1) shall contain information, obtained from the person applying the pesticide, which includes a statement that a pesticide will be applied, the approximate location of the application, and the date of the application.
