A bill to amend 1972 PA 230, entitled "Stille-DeRossett-Hale single state construction code act," (MCL 125.1501 to 125.1531) by adding section 10a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 10A. (1) NOTWITHSTANDING ANY LAW OR RULE TO THE CON-2 TRARY, THE CONSTRUCTION DOCUMENTS FOR NEW CONSTRUCTION, ALTER-3 ATION, REPAIR, EXPANSION, ADDITION, OR MODIFICATION FOR BUILDINGS 4 OR STRUCTURES SHALL BE PREPARED BY OR UNDER THE SUPERVISION OF AN 5 ARCHITECT OR PROFESSIONAL ENGINEER LICENSED UNDER ARTICLE 20 OF 6 THE OCCUPATIONAL CODE, 1980 PA 299, MCL 339.2001 TO 339.2014. 7 THE CONSTRUCTION DOCUMENTS SHALL INCLUDE THE NAME AND ADDRESS OF 8 THE ARCHITECT OR PROFESSIONAL ENGINEER AND SHALL BEAR THAT 9 PERSON'S ORIGINAL SIGNATURE, SEAL, OR STAMP AND THE DATE.

13 AGENCY COSTING LESS THAN \$15,000.00 OR TO A BUILDING OF USE GROUP
14 R-3 OR R-4 CONTAINING NOT MORE THAT 3,500 SQUARE FEET OF CALCU15 LATED FLOOR AREA.

16 (4) AS USED IN THIS SECTION:

17 (A) "INTERIOR DESIGNER" MEANS THAT TERM AS DEFINED IN SEC18 TION 601A OF THE OCCUPATIONAL CODE, 1980 PA 299, MCL 339.601A.
19 (B) "INTERIOR DESIGN DOCUMENTS" MEANS DOCUMENTS REFLECTING
20 THE ACTIVITIES DESCRIBED IN SECTION 601(10) OF THE OCCUPATIONAL
21 CODE, 1980 PA 299, MCL 339.601, PERFORMED BY AN INTERIOR
22 DESIGNER.

23 Enacting section 1. This amendatory act does not take24 effect unless Senate Bill No. 1215

25 of the 91st Legislature is enacted into26 law.
