November 4, 2004, Introduced by Reps. Williams, Adamini, Vagnozzi and Phillips and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 16s of chapter XVII (MCL 777.16s), as amended
by 2003 PA 183.

CHAPTER XVII

Sec. 16s. This chapter applies to the following felonies
enumerated in chapter 750 of the Michigan Compiled Laws:
