## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER XI

Sec. 2b. (1) The court may place an individual convicted of a violation described in subsection (4) on probation for any term 4 of years but not less than 5 years.

- (2) If the individual is placed on probation under this section, the court may order the individual, as a condition of probation, not to engage in all of the following conduct:
- (a) Reside in housing that is located within 1 mile of a school.
  - (b) Enter upon school property.
  - (3) An individual placed on probation under this section is
