## SUBSTITUTE FOR HOUSE BILL NO. 4716

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 41309 (MCL 324.41309), as added by 2003 PA 270.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 41309. (1) A person who violates section -41303 or who
- 2 knowingly violates section 41305 or a permit issued under section
- 3 41305 is guilty of a felony punishable by imprisonment for not more
- 4 than 5 years or a fine of not more than \$250,000.00, or both. In
- 5 addition, the person 41303(2) IS SUBJECT TO A CIVIL FINE OF NOT
- 6 MORE THAN \$100.00.
- 7 (2) A PERSON WHO VIOLATES SECTION 41303(1), OR A CONDITION OF
- 8 A PERMIT ISSUED UNDER THIS PART, WITH RESPECT TO A RESTRICTED
- 9 SPECIES IS SUBJECT TO A CIVIL FINE OF NOT MORE THAN \$5,000.00. A
- 10 PERSON WHO VIOLATES SECTION 41303(1), OR A CONDITION OF A PERMIT
- 11 ISSUED UNDER THIS PART, WITH RESPECT TO A PROHIBITED SPECIES IS

- 1 SUBJECT TO A CIVIL FINE OF NOT MORE THAN \$10,000.00.
- 2 (3) A PERSON WHO VIOLATES SECTION 41303(1) KNOWING THE
- 3 POSSESSION IS UNLAWFUL OR WHO WILLFULLY OR IN A GROSSLY NEGLIGENT
- 4 MANNER VIOLATES A CONDITION OF A PERMIT ISSUED UNDER THIS PART IS
- 5 GUILTY AS FOLLOWS:
- 6 (A) FOR A VIOLATION INVOLVING A RESTRICTED SPECIES, THE PERSON
- 7 IS GUILTY OF A MISDEMEANOR AND MAY BE IMPRISONED FOR NOT MORE THAN
- 8 1 YEAR AND SHALL BE FINED NOT LESS THAN \$1,000.00 OR MORE THAN
- 9 \$10,000.00.
- 10 (B) FOR A VIOLATION INVOLVING A PROHIBITED SPECIES, THE PERSON
- 11 IS GUILTY OF A FELONY AND MAY BE IMPRISONED FOR NOT MORE THAN 2
- 12 YEARS AND SHALL BE FINED NOT LESS THAN \$2,000.00 OR MORE THAN
- 13 \$20,000.00.
- 14 (4) A PERSON WHO, WITH INTENT TO DAMAGE NATURAL, AGRICULTURAL,
- 15 OR SILVICULTURAL RESOURCES:
- 16 (A) VIOLATES SECTION 41303(1) WITH RESPECT TO A RESTRICTED
- 17 SPECIES OR POSSESSES A NONNATIVE FISH OR AQUATIC PLANT IS GUILTY OF
- 18 A FELONY AND MAY BE IMPRISONED FOR NOT MORE THAN 2 YEARS AND SHALL
- 19 BE FINED NOT LESS THAN \$1,000.00 OR MORE THAN \$250,000.00.
- 20 (B) VIOLATES SECTION 41303(1) WITH RESPECT TO A PROHIBITED
- 21 SPECIES OR POSSESSES A GENETICALLY ENGINEERED FISH OR AQUATIC PLANT
- 22 IS GUILTY OF A FELONY AND MAY BE IMPRISONED FOR NOT MORE THAN 4
- 23 YEARS AND SHALL BE FINED NOT LESS THAN \$2,000.00 OR MORE THAN
- 24 \$500,000.00.
- 25 (5) A PERSON WHO SELLS OR OFFERS TO SELL A RESTRICTED SPECIES
- 26 IS SUBJECT TO A CIVIL FINE OF NOT LESS THAN \$1,000.00 OR MORE THAN
- 27 \$10,000.00. A PERSON WHO SELLS OR OFFERS TO SELL A PROHIBITED

- 1 SPECIES IS SUBJECT TO A CIVIL FINE OF NOT LESS THAN \$2,000.00 OR
- 2 MORE THAN \$20,000.00.
- 3 (6) A PERSON WHO VIOLATES SECTION 41305 IS GUILTY AS FOLLOWS:
- 4 (A) FOR A VIOLATION INVOLVING A RESTRICTED SPECIES OR A
- 5 NONNATIVE FISH OR AOUATIC PLANT, THE PERSON IS GUILTY OF A
- 6 MISDEMEANOR AND MAY BE IMPRISONED FOR NOT MORE THAN 6 MONTHS AND
- 7 SHALL BE FINED NOT LESS THAN \$500.00 OR MORE THAN \$5,000.00.
- 8 (B) FOR A VIOLATION INVOLVING A PROHIBITED SPECIES OR A
- 9 GENETICALLY ENGINEERED FISH OR AQUATIC PLANT, THE PERSON IS GUILTY
- 10 OF A MISDEMEANOR AND MAY BE IMPRISONED FOR NOT MORE THAN 1 YEAR AND
- 11 SHALL BE FINED NOT LESS THAN \$1,000.00 OR MORE THAN \$10,000.00.
- 12 (7) A PERSON WHO VIOLATES SECTION 41305 WITH RESPECT TO A
- 13 RESTRICTED SPECIES OR NONNATIVE FISH OR AQUATIC PLANT AND WHO KNOWS
- 14 OR SHOULD KNOW THE IDENTITY OF THE RESTRICTED SPECIES OR THAT THE
- 15 ORGANISM, WHETHER A RESTRICTED SPECIES OR OTHER FISH OR AQUATIC
- 16 PLANT, IS NONNATIVE IS GUILTY OF A MISDEMEANOR AND MAY BE
- 17 IMPRISONED FOR NOT MORE THAN 1 YEAR AND SHALL BE FINED NOT LESS
- 18 THAN \$1,000.00 OR MORE THAN \$10,000.00.
- 19 (8) A PERSON WHO VIOLATES SECTION 41305 WITH RESPECT TO A
- 20 PROHIBITED SPECIES OR A GENETICALLY ENGINEERED FISH OR AQUATIC
- 21 PLANT AND WHO KNOWS OR SHOULD KNOW THE IDENTITY OF THE PROHIBITED
- 22 SPECIES OR THAT THE FISH OR AQUATIC PLANT IS GENETICALLY
- 23 ENGINEERED, RESPECTIVELY, IS GUILTY OF A FELONY AND MAY BE
- 24 IMPRISONED FOR NOT MORE THAN 2 YEARS AND SHALL BE FINED NOT LESS
- 25 THAN \$2,000.00 OR MORE THAN \$20,000.00.
- 26 (9) A PERSON WHO VIOLATES SECTION 41305 KNOWING THE
- 27 INTRODUCTION IS UNLAWFUL, IS GUILTY AS FOLLOWS:

- 1 (A) FOR A VIOLATION INVOLVING A RESTRICTED SPECIES OR
- 2 NONNATIVE FISH OR AQUATIC PLANT, THE PERSON IS GUILTY OF A FELONY
- 3 AND MAY BE IMPRISONED FOR NOT MORE THAN 2 YEARS AND SHALL BE FINED
- 4 NOT LESS THAN \$1,000.00 OR MORE THAN \$250,000.00.
- 5 (B) FOR A VIOLATION INVOLVING A PROHIBITED SPECIES OR A
- 6 GENETICALLY ENGINEERED FISH OR AQUATIC PLANT, THE PERSON IS GUILTY
- 7 OF A FELONY AND MAY BE IMPRISONED FOR NOT MORE THAN 4 YEARS AND
- 8 SHALL BE FINED NOT LESS THAN \$2,000.00 OR MORE THAN \$500,000.00.
- 9 (10) A PERSON WHO, WITH INTENT TO DAMAGE NATURAL,
- 10 AGRICULTURAL, OR SILVICULTURAL RESOURCES, VIOLATES SECTION 41305 IS
- 11 GUILTY AS FOLLOWS:
- 12 (A) FOR A VIOLATION INVOLVING A RESTRICTED SPECIES OR
- 13 NONNATIVE FISH OR AQUATIC PLANT, THE PERSON IS GUILTY OF A FELONY
- 14 AND MAY BE IMPRISONED FOR NOT MORE THAN 3 YEARS AND SHALL BE FINED
- 15 NOT LESS THAN \$1,000.00 OR MORE THAN \$500,000.00.
- 16 (B) FOR A VIOLATION INVOLVING A PROHIBITED SPECIES OR A
- 17 GENETICALLY ENGINEERED FISH OR AQUATIC PLANT, THE PERSON IS GUILTY
- 18 OF A FELONY AND MAY BE IMPRISONED FOR NOT MORE THAN 5 YEARS AND
- 19 SHALL BE FINED NOT LESS THAN \$2,000.00 OR MORE THAN \$1,000,000.00.
- 20 (11) SUBSECTIONS (3), (4), AND (9) DO NOT APPLY BEFORE
- 21 NOVEMBER 1, 2005 TO VIOLATIONS INVOLVING SPECIES OTHER THAN FISH.
- 22 SUBSECTIONS (6), (7), (8), AND (10) DO NOT APPLY BEFORE NOVEMBER 1,
- 23 2005.
- 24 (12) IN ADDITION TO ANY OTHER CIVIL OR CRIMINAL SANCTION
- 25 IMPOSED UNDER THIS SECTION, A PERSON WHO VIOLATES THIS PART
- 26 is liable for any damages to natural resources resulting from the
- 27 violation, including, but not limited to, costs incurred to prevent

- or minimize such damages. 1
- 2 (13) THIS PART DOES NOT APPLY TO ACTIVITIES AUTHORIZED UNDER
- 3 THE MICHIGAN AQUACULTURE DEVELOPMENT ACT, 1996 PA 199, MCL 286.871
