

SUBSTITUTE FOR
HOUSE BILL NO. 4929

A bill to amend 1937 (Ex Sess) PA 4, entitled

"An act relative to continuing tenure of office of certificated teachers in public educational institutions; to provide for probationary periods; to regulate discharges or demotions; to provide for resignations and leaves of absence; to create a state tenure commission and to prescribe the powers and duties thereof; and to prescribe penalties for violation of the provisions of this act,"

by amending section 1 of article IV (MCL 38.101), as amended by 1993 PA 60, and by adding section 1a to article IV.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

ARTICLE IV

Sec. 1. ~~Discharge~~ **EXCEPT AS OTHERWISE PROVIDED IN SECTION 1A OF THIS ARTICLE, DISCHARGE** or demotion of a teacher on continuing tenure may be made only for reasonable and just cause and only as provided in this act. This act does not prevent any controlling

13 **SCHOOL CODE, 1976 PA 451, MCL 380.1230D AND 380.1535A. TO THE**
14 **EXTENT THAT ANY PROVISION OF THIS ARTICLE IS INCONSISTENT WITH**
15 **THOSE SECTIONS OF LAW, THIS ARTICLE DOES NOT APPLY TO THE TEACHER.**
