THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6. A cooperative library shall include those areas

- 2 (e) Combinations of counties or portions of counties serving a
- 3 population of at least 50,000, if the region served has a
- 4 population of 35 or fewer persons per square mile.
- 5 (f) The area covered by a cooperative library shall recognize
- 6 the geosocioeconomic conditions within that area and regions
- 7 established for governmental purposes throughout the state. A local
- 8 board placed in a cooperative library shall have the option to
- 9 petition the department to be placed in a different cooperative
- 10 library or to join with other local boards to form a cooperative
- 11 library under this act. A local board serving an area adjoining
