A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding sections 709 and 711.

- 2 OPERATOR'S OR CHAUFFEUR'S LICENSE AS DESCRIBED IN SECTION 310(17)
- 3 OF THE MICHIGAN VEHICLE CODE, 1949 PA 300, MCL 257.310, OR A
- 4 VERTICAL OR PORTRAIT STATE OF MICHIGAN IDENTIFICATION CARD
- 5 DESCRIBED IN SECTION 2 OF 1972 PA 222, MCL 28.292, SHALL NOT
- PURCHASE OR ATTEMPT TO PURCHASE ALCOHOLIC LIQUOR AT RETAIL.
