May 3, 2005, Introduced by Reps. Hansen, Schuitmaker, Pavlov, Jones, Wenke, Ball, Huizenga, Farhat, Elsenheimer, Kooiman, Walker, Vander Veen, Ward, Gillard and Emmons and referred to the Committee on Natural Resources, Great Lakes, Land Use, and Environment.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 41323.

- 1 SEC. 41323. THE COUNCIL SHALL DO ALL OF THE FOLLOWING:
- 2 (A) ANNUALLY SUBMIT TO THE LEGISLATURE A REPORT MAKING
- 3 RECOMMENDATIONS FOR ADDITIONS TO THE LISTS OF SPECIES THAT ARE
- 4 PROHIBITED SPECIES.
 - (B) ESTABLISH CRITERIA FOR IDENTIFYING WATERBODIES INFESTED BY PROHIBITED SPECIES.
 - (C) PREPARE AND ANNUALLY UPDATE A LIST OF INFESTED
- 8 WATERBODIES, BY SPECIES. THE COUNCIL SHALL SUBMIT THE LIST AND
- 9 UPDATES TO THE DEPARTMENT AND THE LEGISLATURE.
