October 6, 2005, Introduced by Reps. Nofs, Meyer and Taub and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled  
 "The code of criminal procedure,"  
 by amending section 16d of chapter XVII (MCL 777.16d), as amended  
 by 2002 PA 269.
