## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1091. (1) THE DIRECTOR OF THE DEPARTMENT OF COMMUNITY
- 2 HEALTH OR HIS OR HER AGENT SHALL SEEK APPROVAL FROM THE CENTERS FOR
- 3 MEDICARE AND MEDICAID SERVICES TO AMEND THE EXISTING HOME- AND
- 4 COMMUNITY-BASED SERVICES WAIVER TO INCLUDE FUNDING FOR THE HOUSING
- 5 COMMISSION ASSISTED LIVING PROGRAM FOR UP TO 600 INDIVIDUALS IN AN
- 6 ELIGIBLE HOME FOR THE AGED OR FOR LICENSED MEDICAID PROVIDERS
