January 25, 2005, Introduced by Senator CHERRY and referred to the Committee on Technology and Energy.

A bill to amend 1986 PA 32, entitled "Emergency telephone service enabling act,"

(MCL 484.1101 to 484.1717) by adding section 408a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- SEC. 408A. (1) ANY ENTITY THAT INSTALLS OR OPERATES A PRIVATE

 BUSINESS SWITCH SERVICE AND PROVIDES TELECOMMUNICATIONS FACILITIES

 OR SERVICES TO BUSINESSES SHALL ASSURE THAT THE SYSTEM IS CONNECTED

 TO THE PUBLIC SWITCHED NETWORK IN A MANNER THAT CALLS TO 9-1-1

 RESULT IN AUTOMATIC NUMBER AND LOCATION IDENTIFICATION.
 - (2) FOR BUILDINGS HAVING THEIR OWN STREET ADDRESS AND CONTAINING WORKSPACE OF 40,000 SQUARE FEET OR LESS, LOCATION IDENTIFICATION SHALL INCLUDE THE BUILDING'S STREET ADDRESS. FOR BUILDINGS HAVING THEIR OWN STREET ADDRESS AND CONTAINING WORKSPACE

- 25 BUILDING IS SERVICED BY ITS OWN MEDICAL, FIRE, AND SECURITY
- 26 PERSONNEL.
- 27 (5) BUILDINGS IN COMMUNITIES NOT SERVICED BY ENHANCED 9-1-1

- 1 SERVICE ARE EXEMPT FROM THIS SECTION.
- 2 (6) THIS SECTION DOES NOT APPLY TO ANY PBX TELEPHONE EXTENSION

- 13 (8) THE CMRS SUPPLIERS, LOCAL EXCHANGE PROVIDERS, AND PRIVATE
- 14 ENTITIES MAY APPLY TO THE FUND CREATED UNDER SECTION 407 TO RECOVER
- 15 COSTS REQUIRED AS A RESULT OF THE ORDER ISSUED UNDER THIS SECTION.
