A bill to amend 1909 PA 283, entitled

"An act to revise, consolidate, and add to the laws relating to the establishment, opening, discontinuing, vacating, closing, altering, improvement, maintenance, and use of the public highways and private roads; the condemnation of property and gravel therefor; the building, repairing and preservation of bridges; maintaining public access to waterways under certain conditions; setting and protecting shade trees, drainage, and cutting weeds and brush within this state; providing for the election or appointment and defining the powers, duties, and compensation of state, county, township, and district highway officials; and to prescribe penalties and provide remedies,"

by amending section 10 (MCL 224.10), as amended by 2004 PA 516.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 10. (1) The clerk and the members of a board of county
 - road commissioners are subject to 1968 PA 317, MCL 15.321 to
- **3** 15.330.
 - (2) The board of county road commissioners shall employ a

- 1 competent county highway engineer who shall make surveys ordered by
- 2 the board, prepare plans and specifications for roads, bridges, and
- 3 culverts, and exercise general supervision over construction to
- 4 insure that the plans and specifications are strictly followed. Two
- 5 or more adjoining counties may employ the same engineer, if the
- 6 work in 1 or more of the counties is not enough to employ the whole
- 7 time of the engineer. The engineer employed by the board shall be
- 8 known as the county highway engineer.
- 9 (3) The board may also engage other professional and
- 10 consultant services as it considers necessary to implement this act
- 11 and promote efficiency and economy in the operation of the county
- 12 road system. The board may also employ other necessary laborers and
- 13 may purchase machines, tools, appliances, and materials which it
